Evangelism Work Area Reports Progress

Members of the Commission on Evangelism reported Sunday, Feb. 3, on progress in carrying out the "Great Commission" and took part in the services that morning.

Plans for television broadcast are "on hold" at the present time, Palmer Williams, television broadcast chairperson, reported at a Commission meeting Jan. 28.

Due to the high cost quoted by the television station in Panama City, "the probability of it being Channel 13 is very low," Williams said. Inquiries are being made into the possibility of local station broadcast.

"We will lay a firm foundation and do a lot of leg-work," Williams said. "We've got a lot to learn about television broadcast."

Ruth McInvale, "We Care" chairperson, reported new approaches to "key in on new members." These include a brochure describing Sunday school classes and other Trinity programs, greeters to meet visitors, visitor follow-up, and recognition of new

Dr. Gene Davidson, Cottage Prayer chairperson, reported a "Ten Brave Christians" program will be carried out in April "if there is a response from people of the Church."

It has been determined that it would not be "feasible at this time to consider the purchase or leasing of bus transportation." It was emphasized, however, that the Transportation Committee would arrange transportation to the Church for anyone needing it.

"It is one of the greatest things that has happened at Trinity," Elaine Smith said of changes recently made in the Sunday evening service. Her committee is responsible for the transformation into a "spirit-filled" service.

She urged participation in the service and said, "Unless we share the Good News, we're not going to see Trinity shining as it should for the Lord."

Rev. Harold Brown closed the Jan. 28 meeting by asking, "How many of you have spoken about, or shared with others, the love of Christ? I would challenge you to discipline yourself to seek the opportunity of sharing Christ, particularly with those who do not know Christ."

10% Increase in Pledges Needed to Meet Budget

The congregation at the three morning worship services Sunday, January 26, was asked to increase their pledges by 10 percent to make up a deficit of \$28,000 in financing the program of the church for 1975.

The Administrative Board at its meeting on January 14 recommended that a final appeal be made to the membership to avoid abandoning

some benevolences and reducing the ministerial staff and some of the planned programs.

The program for 1975 adopted by the Administrative Board last November after several months' study and planning is expected to cost \$266,000, 12 percent of which represents inflated cost of operating at the same level as last year. David Kerns, chairman of the Finance Committee, said only 11 percent of the total budget is for discretionary programs, and 89 percent represents fixed expenses which cannot be reduced.

"If each family who has pledged will increase their giving 10 to 15 percent, we can make up the shortage," Council of Ministries Chairman Robert Peirce told the congregation. "We're confident that Trinity can support the program to which we are committed," he said.

Palmer Williams told why he thinks making a pledge is important for every church member. "When I joined Trinity, I made a personal commitment to Christ. I then learned that only through members making a pledge could the church, through its programs, make its commitment to Christ. I realized then that I could better serve my church by pledging," he said

Administrative Board Chairman Jack Mowell said that "making a personal commitment is a private matter between oneself and God." He asked the membership to prayerfully think about the church's needs and make pledges accordingly so that its program may move forward.

Trinity's Radio Ministry Is On The Air; All's Well With Blalock At The Console

Exactly at 9 o'clock each Sunday morning a small red light comes on in the balcony railing of Trinity's sanctuary. Minister Ed Norman steps into the pulpit and begins his sermon. Trinity's morning worship service is on the air!

WTNT Radio's audience hears well modulated voices — both spoken and sung. The practiced microphone technique of songleader Walter James or the varying voice of the first time soloist who moves back and forth before the mike are both tuned to their best advantage. Operating the sound system at a console in the balcony is Thomas J. Blalock. He's been Trinity's broadcast "producer" since 1967.

An experienced radio technician, Blalock talks around the world over his own amateur radio band. His hobby as an amateur radio operator became a service when he used the airwaves as a "phone patch" between servicemen's parents and their sons in remote areas of the world during World War II and since.

He also had a recording studio in his home where he cut records for fledgling singers, speeches for politicians, and voice "letters" from college girls to their boyfriends in the service.

Blalock brings still another talent into play as he operates Trinity's sound system. He was a baritone who sang ballads with orchestras in the days of the "Big Name" bands.

When Tallahassee's first radio station — WTAL — went on the air in 1934, auditions were held to select a singer to begin the station's broad-

casting with a selection of songs. Blalock was chosen and serenaded the station's birth for 45 minutes. He no longer sings but he knows when Trinity's choir is about to hit a high note and adjusts the sound accordingly.

He's retired now from working with the State Comptroller and Florida Revenue Commission and emphasizes that it was due to 35 years' service, not his age.

Blalock wasn't in his usual place at the balcony console for several weeks beginning November 17. He was recuperating from surgery. Without two fingers raised signaling two minutes to air time, scheduling of the start of the morning sermon may have been off a few minutes, and the sound, both to listeners in the sanctuary and at home, may have had its ups and downs.

On January 12 Blalock returned. The red light sends out its signal again, reassuring Trinity's ministers and municians they are being heard.

Ministerial Scholarship Fund Gaining Support

Contributions to the Rev. Ralph Jones Ministerial Scholarship Fund now total \$358. The fund was established in memory of the Homestead minister who grew up in Tallahassee and Trinity. He died suddenly in December while serving as pastor of Silver Palm United Methodist Church.

The fund will be used to provide money for young men and women entering the ministry of the United Methodist Church. Rev. Jones' son, Timothy Jones, is already attending Florida Southern College for this purpose and will be the scholarship's first recipient.

COMMENT:

THE SPIRIT WITHIN TRINITY



One of the problems in writing a column a week or more before the publication actually gets into the hands of the congregation is how to write news so that it is still "news" when it is read. For example, I am writing these lines on Saturday afternoon, January 25. Tomorrow Dave Kerns (chairman of the Finance Committee), Bob Peirce (chairman of the Council on Ministries), Jack Mowell (chairman of the Administrative Board), and Palmer Williams (one of our younger members of the Administrative Board and Finance Committee with a personal testimony to give) will have 15 minutes during each of the three morning worship services to make a presentation.

Their presentation will fulfil a decision of the Administrative Board in the January meeting to tell the finance story to the congregation with the hope that as more of us become aware of the need there will be a response which will enable us to reach our 1975 proposed budget and program goal of \$266,000. At this moment we are about \$28,000 short.

As I write these lines I am confident that we will move a long way toward our goal and perhaps even reach it. Already a number of Trinity members have called the church office asking to increase their pledges, and others have indicated that they are planning to make an increase. At this moment increases have ranged from \$10 to \$25 a month.

Whether we reach our goal or not I will be pleased with the results, for this whole "extra push" approach to our need has come spontaneously from the membership of this church. There have been no "pressure tactics" by the staff or by the leadership of the church. The initiative has come from within the membership of Trinity. And that is from where it ought to come. The fact that it has come in the way it has, and in the spirit it has, only serves to re-emphasize the good spirit that prevails here. I just want you to know that I appreciate it.

In the last issue of the Monthly Tidings we presented a "profile of Trinity giving" which mentioned among other things statistics concerning those from whom no pledge has been received. Some people have suggested that these are the people to whom we should turn for the money needed to fulfil our program needs. One insight into this sort of proposal was given by a Board member who asked me in private, "If you had an emergency in the church and needed funds to meet that emergency, to whom would you go: to those who already give heavily to the program of the church or to those who do not give?" My answer: "I'd go to YOU who already are giving!" As a further insight here, your business manager, Mrs. Lisa Miley, and I have gone over the list of those who have made no pledge to date. Many are widows whose very limited incomes already have made each new day an economic crisis in these days of inflation. Some are college students. Some are long-time members of Trinity who for various reasons never have made a practice of pledging. After a study of this segment of our membership we were convinced all the more that we would have to turn to those who are contributing most heavily to the program for any additional funds needed. (By the way, we noted that some of those who are unable to give consistently to the program of Trinity now did through the years of their active life give of themselves to their church.)

Another matter in which I know you will be interested is in connection with something we began here at Trinity two years ago in helping to get underway in East Central Nigeria a program of rehabilitation. At that time we began supporting Richard Ezenwukwa, helping him to obtain needed training at Florida State University.

A year before Richard graduated he was joined by a cousin from Nigeria who was studying accounting. When the tragedy of Richard's sudden death became known, his cousin, along with all of us, was distressed about the fact that need was still there for someone to do the work that Richard had set out to do.

Recently this young Nigerian cousin of Richard's announced that he was changing his course of study from accounting to education for special needs and he plans to return to East Central Nigeria to take up the work that Richard had intended to do.

This young man's name is Kene Ezechi. He has been attending Trinity regularly for many months and recently joined this church. One of our members is providing his tuition at Florida State. Others have been supplementing his living expenses (he does work in his spare time but needs additional funds to subsist). Additional help has been coming from a special fund here at Trinity. As time goes on you will have an opportunity, as many of us already have, of getting acquainted with Kene Ezechi.

Where Needs Were UMW Were in 1974

Supportive concern and social involvement from Nigeria to Japan, for people around the world and here in Tallahassee. This was the scope of the work of Trinity's United Methodist Women during 1974, according to an annual report prepared by President Mrs. Griffith Pugh.

In the Tallahassee area, the UMW division on Supportive Community, Mrs. Robert O. Lawton, chairman, sponsored a welcoming tea for international students, a luncheon for senior members of Trinity, contributed to day camp (COCO) for underprivileged children, helped deliver Meals on Wheels and gave \$200 to the project, provided meals for Terrell House and participated in Tallahassee Urban Ministries.

With Mrs. Ed Norman as chairman, the division on Christian Global Concerns assisted with an anniversary tea benefitting Japanese International University, sponsored an appreciation day dinner for the late Richard Ezenwukwa of Nigeria, participated in Trinity's weekend in missions with the Bill Matthews family, former missionaries to the Philippines and Fiji Islands, and cosponsored Thanksgiving dinner for international students.

UMW's Christian Social Involvement, Mrs. Robert Short, chairman, sought to inform and challenge women to responsible action in the political area; cosponsored a Sunday evening program with a legislator answering questions on legislation; and gave special emphasis to child care center licensing. Other activities of this group included a card sale for UNICEF, clothing drive for Church World Service, sewing layettes for Leon Associated Charities and CWS, and a benefit for Florida migrants.

More than \$1,000 worth of clothing, shoes and household linens were distributed through the Leon County Welfare Department by the Community Welfare division, Mrs. Myrtle Metz, chairman. Thanksgiving baskets were delivered to the needy.

UMW also assisted with Trinity's Sesquicentennial celebration and carried out projects helpful to the church's total program.

Local Churches Asked to Find Missionaries

The Board of Global Ministries of the United Methodist Church is preparing 53 new missionaries for commissioning and has openings throughout the world for 123 more. When all positions are filled this will increase the present total of 851 in the field by another 176

The church's increased response to missionary support, to World Service and Women's Division funds has turned around the previously held belief that the Board of Global Ministries would have difficulty in sending out more missionaries.

Local churches have the responsibility to help find committed Christians, persons of recognized professional competence, interpersonal skills and resilience, to fill the openings. Persons may apply to the Board of Global Ministries, Personnel Dept., Room 1373, 475 Riverside Drive, New York, N. Y. 10027.

Pastors, teachers, doctors, and other skilled persons are needed in many foreign countries. Detailed needs may be obtained from Trinity's ministers.

Grist From Mills

CHRISTIAN EDUCATION BEGINS . . .

Where does Christian education begin? It seems obvious that it does not begin in the church. It begins in the home. Historically the church was in homes. "Interpretation took place primarily in the home. For many years the law of Massachusetts required that all families catechize their children and servants at least once a week." (p. 15, Values for Tomorrow's Children, Westerhoff.)

Perhaps even more shaking than the law of Massachusetts was the fact that in the beginning the church opposed Sunday school. In 1780 a newspaper man by the the name of Robert Raikes became concerned with delinquency and illiteracy in the cities of England. He took into a private home children 6 to 14 years old and on Sunday (the only day off from the factory these children had) attempted to teach them to read and write. The Bible was an obvious choice for a textbook. In 36 years a half million children were involved in these selfsupporting lay organizations known as Sunday schools.

The church opposed this movement because it broke the fourth commandment concerning the Sabbath; and the privileged class did not believe these children ought to be educated. They even described the Sunday schools as instruments of the devil.

The idea for Sunday school found sympathy across the ocean in America. Through the growth of America westward and a series of many events, the Sunday school has slowly evolved into the kind of structure we have today.

However, somewhere in the evolution we have lost the idea, and the foundation that our basic Christian education is in the home. We set our children's minds and attitudes toward the *total* church by our feelings, thoughts and commitments to it. For religious education we have evolved to an attitude of "let the church do it."

The church can do its part but *only* a part. What happens in your home when your child comes home excited about church school? Do you say, "Not now, the game it on"? Do you share in your child's excitement? What happens when you get excited about an event you have in church school? Do you share it with your family? How about with a close friend or neighbor?

How about family discussions on religion, God, and spiritual growth? These are necessary if our ministry is to be a total success in building a foundation for lifetime commitment.

The time is *now* for us to join together — home and church — to share our hopes and dreams for our Christian education program here at Trinity. Share with your age level coordinators or with me your ideas for improving this program. We have age-level councils who will listen and work to develop a shared ministry for our Christian growth both in church and at home.

ON CHRISTIAN BELIEFS

A little girl was asked, "Mary, how do you go about drawing a picture?" She replied, "First, I think; and then I draw a line around it."

In a sense that is how creeds and doctrinal statements are drawn. They are born of experience. Our Christian creeds are the result of the experience of the church. That experience is tested and interpreted in the light of Scripture. In other words, the great beliefs of the church are not concocted out of the heads of a group of church philosophers who sit in some isolated den and spin doctrines like spiders spin webs.

Furthermore, no creed, no doctrinal statement, no system of theology is final and finished. Otherwise they become idols to be worshipped in the place of God. The God who revealed Himself in Jesus Christ cannot be captured in anyone's creed or theology.

Recognizing the limitations placed upon any attempt to formulate statements about God, we still are under obligation continually to try to verbalize our understanding of Him. We need to move beyond those who think of God simply as an oblong blur.

Our *Tidings* editor has suggested that we take some space in this monthly publication to present some statements relative to United Methodist beliefs and our Christian understanding of God. This I will attempt to do. And in terms of the space that is available from month to month I will make some statements about God, Jesus Christ, the Holy Spirit, man, the Church, life after death, the Second Coming, the Kingdom of God, and other facets of the Christian faith and life.

I begin where the Bible begins: "In the beginning God . . ." I BE-LIEVE IN GOD! Does that mean that I am naive? There are people these days who suggest that it is a sign that "you aren't with it" to believe in God.

I disagree. The very facts that modern science has opened new doors to understanding the universe and in some degree has "unscrewed the inscrutable," and has tossed back the veil to disclose some of the great mystries of this creation, have contributed to the deepening and strengthening of my own faith in God. In fact, I am convinced that you have to be more gullible and closed-minded to reject God than to believe in God.

Some of the attacks that are made upon the Christian faith are made in the name of science. I have to say that they are made "in the name of science" rather than "by scientists" because I know personally many scientists who have a firm faith in God and in Jesus Christ. On the other hand, other scientists with the same scientific background do not believe in God. Sometimes the attack on the Christian faith comes out something like this: We all begin with things that we can see and measure, which can be tested in a test tube or examined under a microscope. This is fact; this is knowledge. Now, we can go on and speculate on what lies beyond the observable and measurable. Science deals with the known facts; religion deals with faith. But this is not so . We all deal with faith. Whether we are scientists or whether we aren't we all deal with faith.

Just assuming that there is a world out here beyond our own senses is an act of faith. All we know of the world is our experience of it. We don't know the world. All I know of you is my experience of you. And you don't

know me; all you know is your experience of me. If we are to know anything about what is, our knowledge must be built upon the "stuff" which is thrust into our experience. Einstein said, "The object of all science is to coordinate our experiences and to bring them into a logical system." Another scientist named Niels Bohr said, "The task of science is both to extend the range of our experience and to reduce it to order." In other words, they are suggesting that the subject matter of science is our experience.

Have you thought about how we receive the information about the world we live it? It comes in the form of stimuli striking our nerve endings. Electrical impulses are sent to the brain; the brain interprets those impulses.

I can illustrate it all this way: Suppose you are inside a big box. The box is light-proof and sound-proof. In the box you have a television set, a closed-circuit affair with a camera located up on top of the box. All you know inside the box is what you receive on the television screen. Suppose someone slips in a video tape cassette. And as you watch your set you suddenly exclaim, "Wow!" What's going on out there? Look at those monsters!" There are limitations to every analogy, but this tale of the TV in a real sense is an analogy of our real-life predicament. I have seen even that part about the cassette played out as I have visited folks in the hospital who have been given strong drugs. They have reported to me that there are things in the room that I don't see at all. I have seen men hypnotized who "saw" snakes in their shoes. I have seen things in my dreams that seemed very real to me at the time.

It somtimes comes as a shock to a person to learn that all scientific inquiry rests upon certain assumptions which cannot be proven. One such assumption is that there is a world "out there" that he can know something about. He can't prove that there is a world out there, or that the map of the world in his head actually corresponds to that world. He assumes it. It may be on the basis of evidence, but he assumes it.

What is true of scientific knowledge" also is true of "religious knowledge." Both types of knowledge are rooted in faith. Science cannot disprove God. But science cannot prove God either. However, science can illuminate our faith.

Our knowledge of God is rooted in experience and like all of our knowledge it is based in faith. Our knowledge of God is our basic knowledge in the light of which all of our other experience is interpreted and understood.
