### **Lenten I Share Project to Start**

On the first Sunday of Lent, February 12, the Mission Work Area will invite all people of the churchyoung and old-to participate in a "I care—and I can share" project.

A label that will wrap around a soft drink can and convert it into a bank will be distributed with the church bulletins that Sunday. The label urges church people to give to ease the anguish of world hunger. The Mission Work Area hopes that Trinity members and church school pupils will attempt to fill the banks during the Lenten season and return them as their offering on Easter Sunday.

In previous years members have sacrificed one meal a week or some other item and donated the money they would have spent to the world's hungry. The work area suggests that children participating may decide to give up candy and other snacks and put the money saved in their banks.

For United Methodists, the fight against world hunger is a missional priority. Money given through this Advance Special will go to work to feed hungry people now, eliminate the root causes of famine and malnutrition, affect public policy for fairer distribution of food, develop life styles less consumption-oriented.

On February 12, Elise Lawton will describe her work as president of Church Women United.


On February 19, Pat Crotty will describe her activities as a Church and Community Worker in the Tallahassee District for the United Methodist Board of Global Ministries.

Justice Boyd to Talk At Wills Workshop

Supreme Court Justice Joseph Boyd will be featured speaker at a wills workshop in Trinity's Fellowship Hall at 7:30 p.m., Tuesday, February 28.

Planned by Trinity's Wills and Gifts Committee chaired by Ernest Menendez, the workshop is open to all persons who may have questions about the importance of a will and how one should be drawn. A similar workshop was presented by the committee and attended by a large number of members and friends last year.

Justice Boyd will describe some of the legal entanglements that occur when a person dies without a will. A panel comprised of committee members Bob Parker, Ted Steinmeyer and Rebecca Hawkins will answer questions following Justice Boyd's talk. J. Lewis Hall will introduce the speaker.

Justice Boyd became a member of the Florida Supreme Court in 1969 after having practiced law in Miami for more than 20 years. He was a Dade County Commissioner for ten years and is a former state commander of the American Legion. He received his law degree from the University of Miami.

# **Trinity's 1978 Program Goes Forward** With \$304,000 Pledge Goal Reached

Trinity's ministry and program for 1978 moves forward as planned with the pledge for financial support by its members of \$304,000.

The 1978 pledge goal was reached "through the dedication of devoted members and the total response of the membership," the Financial Committee announced. Following pledge dinners in November and initial contacts, the December Monthly Tidings reported pledges totaling \$181,000 of a needed \$270,000.

A churchwide mission study on the Caribbean Crescent is being planned for March 5-9 by the Work Area on Missions and United Methodist Wo-

The program will begin during morning worship Sunday, March 5, when a guest minister who has served in the chain of islands in the Caribbean will be invited to speak.

During the church school hour, children of all ages will learn about Haiti, Jamaica, Puerto Rico and other countries. That evening at 7 o'clock they will present part of the program to a combined audience of children and adults. Another part of the evening's program will focus on the needs and problems of those countries.

The United Methodist Women will study women of the Caribbean during their general luncheon meeting at noon, Tuesday, March 7. The program is being developed by Nancy Kerce and Emily Ann Zimmerman.

The study will conclude with a churchwide covered dish dinner at 6:30 p.m., Thursday, March 9. The Rev. Gene Zimmerman will show slides and give commentary describing a period of his ministry in the Caribbean. The Youth Choir has been asked to sing music of those countries.

At the end of the evening, an opportunity and course of action by which Trinity members may reach out in mission to the people of Haiti will be presented.



I just found a typographical error in a good book. It leaped off the page and startled me by its presence. But why, I thought, should I be surprised to find one mistake in an otherwise perfect book. The answer I gave to myself is that we seldom see such errors in well printed books, therefore the appearance of one calls quite a lot of attention to itself.

From books my thoughts went to people. Some people scan others for errors. They are quite cognizant of the occasional flaws that are present in all and will remember those long after the good things are forgotten. If you want to compare books to people, it's like saying, "There's the . for us all.

book with the error in it," and completely ignoring all the rest of the good that is contained therein.

If you want to carry the analogy further, it's impossible to print a book without some mistakes, and by the same token, it's hard to live a life without some. In spite of our best efforts to glean them all out, they still appear. To act at all is to make some mistakes.

But we don't discard books because of a few errors. We go on to read them and be rewarded by the whole work. If we'd look at one another that way and be reminded that this is precisely what God does, life would be richer

# **Christian Education Comments**

by John Green Social Principles of The United Methodist Church: The Nurturing

The social principles of the United Methodist Church, adopted by the 1976 General Conference, include statements concerning our responsibility as a church community. We should provide opportunities for nurturing human beings into the fullness of their humanity. Primary for Methodism is the Gospel interpretation that all persons are important to God. We thereby support social conditions in which human communities are maintained for the goodness of every per-

The following statements are representative of Methodism:

A. We believe the family to be the basic human community through which persons are nurtured and sustained in mutual love, responsibility, respect, and fidelity.

B. We assert the sanctity of the marriage covenant which is best expressed by love and mutual support.

C. (1) We recognize that sexuality is a good gift of God and we believe persons may be fully human only when that gift is acknowledged and affirmed by themselves, others, and

(2) We reject all sexual expressions which damage or destroy the humanity God gives us.

(3) We insist that all persons are entitled to have their human and civil rights insured, though we do not condone the practice of homosexuality (we believe homosexuals are persons of sacred worth) and consider this practice incompatible with Christian teaching.

D. Decisions concerning abortion should be made after thorough and thoughtful consideration by the parties involved with medical and pastoral counsel.

E. We assert the right of every person to die in dignity, with loving personal care and without efforts to prolong terminal illnesses merely because the technology is available to

The greatest amount of controversy has come from the areas of homosexuality, abortion, and death with dignity. We have the right to investigate these areas ourselves and witness

to the values and principles these issues present to us. It is important to ourselves and upcoming generation to recognize the needs and rights of persons. Included in our sensitivity to others is the Christian obligation to minister to the hurts of people. The United Methodist Church speaks to the problems of life and encourages us to be participants in solving or coping with these problems. It is in our involvement with the issues of life that we witness and respond to God's call to be Christian participants.

A Prayer

Father, we are sometimes frightened by the awareness of things that can and do happen to people; a neighbor dies, a friend is stricken with unexpected illness; and we ourselves are thrust into circumstances we cannot escape. We prefer to live in a world without pain, or tears, or unwanted events, and we have no desire for our lives to be changed once they have been set upon a desired course. But we soon discover this is not the kind of world in which we live.

Disappointment, disease, death are inescapable with us and though we wish to flee, we cannot. Our prayer is then, not to protect us from all harm, much as we would like to ask, but to prepare us to be strong in spirit and know that life is more than meat and raiment; what we eat and wear. Help us to see that we could lose all that we have and still, by Thy grace, possess our souls and feel an inner strength and security that could not be taken away.

Knowing that failure is as much a part of life as success, we ask you to forgive us of our sins; to forgive our neighbors of their sins, and help us to forgive ourselves and our neighbor.

We pray this prayer in the name of our Lord Jesus in whom we see life at its fullest and best.—Amen.

#### THE CHARACTER OF A METHODIST By John Wesley

THE distinguishing marks of a Methodist are not his opinions of any sort. His assenting to this or that scheme of religion, his embracing any particular set of notions, his espousing the judgment of one man or of another, are all quite wide of the point. Whosoever, therefore, imagines that a Methodist is a man of such or such an opinion, is grossly ignorant of the whole affair; he mistakes the truth totally. We believe, indeed, that "all Scripture is given by the inspiration of God;" and herein we are distinguished from Jews, Turks, and Infidels. We believe the written word of God to be the only and sufficient rule both in Christian faith and practice; and herein we are fundamentally distinguished from those of the Romish Church. We believe Christ to be the eternal, supreme God; and herein we are distinguished from the Socinians and Arians. But as to all opinions which do not strike at the root of Christianity, we think and let think. So that, whatsoever they are, whether right or wrong, they are no distinguishing marks of a Methodist.

Neither are words or phrases of any sort. We do not place our religion, or any part of it, in being attached to any peculiar mode of speaking, any quaint or uncommon set of expressions. The most obvious, easy, common words, wherein our meaning can be conveyed, we prefer before others, both on ordinary occasions, and when we speak of the things of God. We never, therefore, willingly or designedly, deviate from the most usual way of speaking; unless when we express Scripture truths in Scripture words, which, we presume, no Christian will condemn. Neither do we affect to use any particular expressions of Scripture more frequently than others, unless they are such as are more frequently used by the inspired writers themselves. It is as gross an error to place the marks of a Methodist in his words, as in opinions of any sort.

Nor do we desire to be distinguished by actions, customs, or usages, of an indifferent nature. Our religion does not lie in doing what God has not enjoined, or abstaining from what he hath not forbidden. It does not lie in the form of our apparel, in the posture of our body, or the covering of our heads; nor yet in abstaining from marriage, or from meats and drinks, which are all good if received with thanksgiving. Therefore, neither will any man, who knows whereof he affirms, fix the mark of a Methodist here,-in any actions or customs purely indifferent, undetermined by

the word of God. Nor, lastly, is he distinguished by laying the whole stress of religion on any single part of it. If you say, "Yes, he is; for he thinks 'we are saved by faith alone:' " I answer, You do not understand the terms. By salvation he means holiness of heart and life. And this he affirms to spring from true faith alone. Can even a nominal Christian deny it? Is this placing a part of religion for the whole? "Do we then make void the law through faith? God forbid! Yea, we establish the law." We do not place the whole of religion (as too many do, God knoweth) either in doing no harm, or in doing good, or in using the ordinances of God. No, not in all of them together; wherein we know by experience a man may labour many years, and at the end have no religion at all, no more than he had at the beginning. Much less in any one of these; or, it may be, in a scrap of one of them: like her who fancies herself a virtuous woman, only because she is not a prostitute; or him who dreams he is an honest man, merely because he does not rob or steal. May the Lord God of my fathers preserve me from such a poor, starved religion as this! Were this the mark of a Methodist, I would sooner choose to be a sincere Jew, Turk, or Pagan.

# "Trinity Took Step Forward in 1977 by Reversing Attendance Decline; Lay Involvement Is Key Factor"

Taking a suggestion from the theme for the campaign to finance Trinity's program for 1978, "A Time for Reflection, A Time for Decision," the Monthly Tidings sought the assistance of Senior Minister Dr. Gene Zimmerman in "reflecting" on 1977.

The theme for the fund-raising program for 1977 was "A Step Forward." Did Trinity United Methodist Church take a step forward during

"Yes," said the Rev. Zimmerman. "Our goal for 1977 was to reverse the decline of the past few years in church school and worship attendance. During 1977 we realized a five percent increase in church school attendance, a six percent increase in church attendance, and eight percent increase in pledging and seven and one-half percent increase in dollars contributed."

"Although I am an anti-numbers person, they are one indicator of movement. These figures represent the conscious involvement of all our people," the Rev. Zimmerman said.

He gave as the reason for this step forward one of Trinity's greatest strengths — broad participation by skilled lay people. "For example, Trinity's Work Area on Education is strong and active. They have enthusiasm and not only give their time, but many of the church school teachers and leaders are trained in education and are very competent. Our minister of education, the Rev. John Green, has worked closely with them and assisted them with materials and resources. And, of course, the financial support the congregation provided was a vital ingredient.

"Our youth program led by the Rev. Phil Roughton has a good balance between study and service. Phil has involved the youth in mission and Bible study as well as recreation," he said. Increased activity by the youth was in part possible with funds in the 1977 budget which provided a van for transportation during the summer months. The Youth Choir went on tour and the youth also used the van for its summer mission project to

Appalachia.

Trinity focused attention and dollars on benevolences and conference apportionments during 1977. Though set by the Annual Conference, Trinity's increased giving, combined with the giving of other Methodist churches, made a vital force in the state, nation and world. In addition, several local service organizations received financial support from Trinity. These included the Salvation Army, Transient and Emergency Aid, Meals on Wheels, Goodwill and Terrell

"When you turn around a big institution, it is like turning a big ship around at sea," the Rev. Zimmerman explained. "During the 50's there was an exodus into the church, in the 60's there was an exodus out of the church. There is a national trend back to religion, but it is on the periphery of the church. Different views about religion are springing up all around us and the mainline Protestant churches continue to lose members.

The Rev. Zimmerman said this confusion of religious belief has caused us to reevaluate ourselves, make the church be clearer what it is about, what it calls us to do.

"In worship services, I am trying to preach as clearly as I know how what the Christian message is. There is so much confusion; I want to make some clear statements about it.

"Trinity has a long history of traditional Methodism; I want us to maintain it," he said. He defined traditional Methodism as "a faith of both the head and the heart, intellectual content and spiritual experience. It has a concern for persons and the quality of their life and calls us to mission at home and abroad. It also means that what we do is in concert with Methodists everywhere."

The Rev. Zimmerman said the momentum gained in 1977 must be maintained and increased. "The decision for our members in 1978 is: Will you be a part of this growing?"

Presently she is employed as secretary to the Assistant Attorney General.

Both her experience as a youth growing up in the church and her work with the junior highs at Trinity for the past year have helped give Cheri an understanding of the problems and needs of the youth of the church, the Rev. Phil Roughton said. As youth co-ordinator, Cheri, along with the minister responsible for youth ministry, works with all the youth activities which take place inthe church. She is a voting member of the Council on Youth Ministries and the Council on Ministries.

"I'm particularly pleased and appreciative when former members of the youth group come back and volunteer to help. That gives us some indication that the church's ministry to young people is significantly influencing their value choices, one of our important goals," said Rev. Roughton.

# "Always a Red Rose"... Mrs. Sellers Is Faithful Home Nursery Visitor

If you have been a member of Trinity and had a baby in any of the years since 1954, chances are you received a visit soon after you returned home from the hospital from Mrs. Owen Sellers. She later placed a single red rose on the altar honoring your baby. Then when your child became a second grader, Mrs. Sellers was his Sunday school teacher.

Helen Sellers has been home nursery visitor and Sunday school teacher for a generation of Trinity members. The late Dr. Glenn James asked her to be home nursery visitor in 1954. She agreed to visit the mother and child when they came home from the hospital and to put the rose on the altar the next Sunday. "Always a red one," Dr. James said. A special silver vase was given to the church in memory of Beryl Collins to hold the roses.

Mrs. Sellers has kept records of the visits-728 in 24 years. From a low of 14 the first year to a high of 49 in 1957, births into the Trinity family held a steady pace. Since 1957 the trend has been downward, with 21, then 18, and 17 in 1977.

Mrs. Sellers and her husband Owen came to Tallahassee in 1931 from Cincinnati, Ohio. They joined Trinity at that time, and for the past 25 of those years, she has been teacher of the second grade class. Elementary Sunday school coordinator Barbara Woolard spoke fondly of this lady who shares with her class many personal experiences and stories. "She's a gracious and soft-spoken woman who is a true delight to those who come in contact with her," she said.

"She's famous in her neighborhood for the 'chewies' she gives to children. Children are always stopping by her house for the butterscotch candy or other goodies she shares with them. Not only does her neighborhood children adore this lady, but her Sunday school class does too," Mrs. Woolard said.

She's a musician with interest in piano, organ, and trumpet. From 1935-1945 she was a music teacher in Havana and Quincy. #### Youth Plan Retreat At St. Simon's Island Weekend of March 3-5


