## **Charge Conference** Will Vote on **Parsonage Plans**

A Charge Conference will meet at Trinity on December 16 following the Christmas Carol Service to give final approval to plans and budget requirements to build a new parsonage for the senior minister.

Architect Joe Clemons has completed plans and specifications for the parsonage and bids are now being obtained from builders.

The Trustees, Finance Committee and Parsonage Committee will hold a joint meeting on December 12 to pass on the plans and develop a budget. An earlier Church Conference voted that the total project not exceed \$130,000.

Approximately \$100,000 of that amount was realized by the sale of the old parsonage on Adams Street and is invested to be earning interest until needed for the construction. Some of the interest is being used to pay rent on a house where the senior minister and his family are living until the new parsonage is ready for

Lynn Wollschlager, a member of the Parsonage Building Committee and a Trustee, said as soon as final approval is given by the Charge Conference the job will be let to the lowest bidder. The house will be built on a lot donated by the Middlebrooks family just off Live Oak Plantation Road.

### Membership Now **Totals 2,629**

Trinity's membership totaled 2,629 at the time of annual reporting at a Charge Conference on November 6. The Rev. Gene Zimmerman reported to Tallahassee District Superintendent Al Vaught that the church gained 59 new members during the year but lost 67.

Attributing to the decrease of eight were the loss of 21 by death, 34 by transfer to other United Methodist churches, 10 to other denominations and two by withdrawal.

New members included 18 by confession of faith, 24 from other United Methodist churches and 17 from other denominations.

## **Pledges Needed if Trinity Is to Fulfill** Its 1980 Mission

Trinity members attending the loyalty dinners in November pledged about \$140,000 toward the church's \$334,000 program and ministry for

Pledge Program Chairman Dean Bunch last week wrote some 600 members who did not attend the dinners, "It is now up to you to determine if Trinity will be able to fulfill its mission in the coming year." Each letter contained pledge and bank cards with which those members unable to attend the dinners may find it easy to make a personal commitment to share in Trinity's ministry.

The Rev. Gene Zimmerman said, "We felt the loyalty dinners were very successful and though we raised only \$140,000 we are confident the whole amount will be pledged. Church finances always rest on an element of faith. In my 25 years as a minister, church members have always underwritten the programeither with a large unexpected gift at the end of the year or overpayment of a pledge," he said.

The church finance secretary reminded Trinity members that those persons using bank draft cards must sign a new card each year in order for the pledge to be honored. All members are requested to fill out and return the bank cards, if that is their choice of payment, even though the pledged amount is the same as it has been during 1979.

An additional \$35,000 was pledged toward the Ministers Retirement Fund. The Florida Annual Conference assigned as Trinity's share of this fund \$47,000 to be paid over a three-year period.

### **UMW Begins Fund** For Funeral Pall

Trinity's United Methodist Women have established a Pall Fund to purchase a funeral pall to be used in church funeral services.

Because of the rising cost of funerals, many churches have turned to the use of palls to spread over the casket and eliminate the need for a blanket of flowers. Use of a pall also removes the need to buy an expensixe casket simply for appearance's


The pall is made of heavy cloth of white, bound around the edges with red cording. A three-foot antique gold cross is outlined in red in the center of the pall.

The funeral pall emphasizes that all are equal in the sight of God and provides a symbol of dignity and equality.

## Some Questions and Answers About Human Rights

We are involved in a churchwide study of human rights. It probably is fair to say that this study will last through the 1980's, that indeed human rights will be the worldwide, overriding question of the next decade.

Would you like to visualize a world in which there was no hunger? Now at least 30 nations allow torture for political opposition. Do you believe that the world can outlaw this deliberate infliction of pain from one human being on another? If our answer is even "perhaps," we will want to be a part of the present struggle to extend to all mankind the blessings of liberty . . . and to the people of our own nation freedom from crime, poverty, and despair.

Q. What are human rights?

A. Those things we can claim as ours solely on the basis of our humanity. They are rights we have in common. They are ours whether or not we accept the responsibility for having them. They are ours if we trample them underfoot or if we value them.

Q. Are human rights based on the Bible?

We are largely indebted to the Greeks and Romans and to the Frenchman Rousseau for the basis of our laws on human rights, but it is scripture that gives us our passion for human rights. Prophetic concern for widows and children and the oppressed, denunciation of solemn assemblies without true compassionthese we get from the Bible. "Let Justice roll down like waters and Righteousness like a never-ending stream." In the 25th chapter of Matthew, Jesus identifies himself with the destitute, those in prison, the naked, the friendless and ends with, "Inasmuch as you have done it unto one of the least of these my brethren, you have done it unto me." This is the biblical touchstone behind Sister Theresa's recent statement: 'They, the destitute, are the body of Christ and by touching them we are touching His body."

**Q.** Why do we seem to think of rights in connection with government?

**A.** It is impossible to think of the protection of rights without calling on

government for protection, control, or arbitration.

Q. What has been done in the UN about defining human rights for world population?

A. In 1948 when Nazism showed plainly that the violation of any person or people debases all humanity the UN adopted the Universal Declaration proclaiming one indivisible body of rights necessary for the preservation of human dignity. The Universal Declaration, however, is a recommendation and is not legally binding.

Two covenants, comprising 30 articles, are legally binding. One defines the economic, social and cultural rights and the other the civil and political rights. The latter, the Covenant on Civil and Political Rights, provides standards that can be measured. Countries that ratify this document become member nations and submit reports to the UN Human Rights Committee on their programs in securing the rights of all their people.

Q. Can you point to any gains made in human rights because of actions by the UN?

**A.** Every member country has to submit its constitution for review by the Human Rights Committee and answer detailed questions about any contradictions seen.

Finland is now revising its constitution to make\_it agree with the covenants. Equador, recently changed from dictatorship to representative government, has made gains in tolerance of its Indian population and now has a literacy rate of 76.6%.

Romania has improved health care and education but needs much improvement in its penal code. The Human Rights Committee pinpointed these needs.

In 1978 the committee questioned the government of the Shah of Iran so sharply that the Iranian representative refused to respond and said he would reply in writing after they had researched the committee's concerns. (New World Outlook, October 1979, p. 28-30)

### Leesburg Life Enrichment Center Opens

The Leesburg Life Enrichment mittee that conducted a successful Center was officially opened at a dedication ceremony conducted at the new facility on Saturday afternoon, November 10. The hour long dedication service began at 2 o'clock and made a fitting climax for a retreat which began on Friday evening at

The 400 or more persons, including both clergy and laity, were housed over night in the four new motel type units, each of which contain 2 double rooms with private baths.

The dinner on Friday, breakfast and lunch on Saturday were served cafeteria style in the dining room located in the Administration Building. This room has a stage at one end and can be quickly converted to an auditorium by removing tables and arranging chairs facing the stage. The dedication service was also held in this room.

The general sessions were conducted in the Meeting Room Building, which contains one large room that will seat 250 persons, and form small rooms, that will accommodate 50 persons each, for smaller group meetings. The large room and one of the small rooms include limited kitchen facilities.

Principal speakers for the retreat included Bishop Carl J. Sanders of the Birmingham Area, Bishop Joel D. McDavid of the Florida Conference and Charles Babcock, a Miami layman who chaired the fund raising com-

## -Roughton's Rappings —

You may have lost the Christmas spirit by now. With store decorations going up just before Halloween and after-Christmas clearance sales falling the day after Thanksgiving (slight exaggeration perhaps), it's a real feat of endurance just to make it to the first week in December with a viable "Ho! Ho! Ho!"—let alone some tinsely expression of the season.

And maybe that's a good thing. If the trend continues, in a few years we'll be able to finish the holiday rush in mid-August and have four full months to relax and anticipate that Currier and Ives Christmas for which I for one deeply yearn every time I see one of their cards or calendars. Fresh fallen snow. A people and package laden sleigh silently weaving its way over gentle slopes toward the golden glow of windows in a wreath bedecked farmhouse, smoke spiraling from brick chimneys toward the twinkling sky.

Peaceful? Yes. Wonderful? For many, yes. Possible? For most, no. Oh, Neiman Marcus, producer of last year's rage—"Chocolate Monopoly games," or some other organization skilled in catering to our every whimsical pleasure could probably work something out—for the right price: "Currier and Ives Christmas Package Deal (includes chestnuts roasting on an open fire) only \$XXXX..."

Even if we could pay the price, the least perceptive of us knows the tranquility ends just over the next hill. There's Ayatollah Khomeini. There's Northern Ireland. There's world starvation. There's corruption in government. There's the homocide rate in Atlanta. There's child abuse. There's the death penalty. There's . . . . Clearly not a Currier and Ives world.

What about "Peace on earth, good will toward men" and all that? Are we to have no peace, no joy? Dimmed though they may have grown, those have certainly been central themes of the Christmas celebration. The problem is to keep them shining brightly.

One way is to work out the sleigh ride if we can. Not literally maybe—but we can look for and plan those things which provided opportunity to slow down for a moment and think about what happened at Christmas. All of us need a little Currier and Ives now and then.

Another way will require a little more work mentally. Depending on how far we want to go with it, it might also require some sacrifice. Rather than attempting to insure our peace or our joy through the preservation of any number of peaceful/joyful traditions, or the creation of synthetic experiences to isolate us from real problems, we can make an honest effort to understand what peace and joy mean—not just for us—but for everyone. With that understanding we can begin to act, make changes in the way we live, or whatever becomes necessary to realize the goal.

The peace and joy experienced from those kinds of choices could easily fuel a Christmas spirit all the way through Easter and back to Christmas again—without a single clearance sale.
