Commissions To Hold Planning Meetings Feb. 8

The commissions that plan and carry out the program and mission of Trinity United Methodist Church will hold organizational meetings on Monday, February 8, beginning with a covered dish supper at 6:30 p.m., in the Fellowship Hall.

Following the supper, Griff Pugh, chairman of the Council on Ministries, Bill Mattice, chairman of the Administrative Board, and Lay Leader Kitty Ball will review Trinity's goals for 1982. The commissions will meet separately to begin their work for the year.

Elected by the Charge Conference last November to serve during 1982, the commissions are Christian Unity and Interreligious Concerns, chaired by Elise Lawton and assisted by staff member Rubie Butterworth; Church and Society, chaired by Giff Hale and assisted by Associate Minister Brent Byerman; Education, chaired by Edna Bennett and assisted by Associate Minister Carol Kowalski; Evangelism, chaired by Peggy Hughes and assisted by Brent Byerman.

Higher Education and Campus Ministry chaired by Myron Blee and assisted by Carol Kowalski; Missions chaired by Vernon and Jamie Parramore and assisted by Rubie Butterworth; and Worship chaired by Kathy Pope and assisted by Dr. Walter Kalaf and James C. Davis.

The same staff and ministerial support will be assigned to the commissions throughout 1982 to give assistance and guidance as needed. In addition, Dr. Kalaf will work with the Board of Trustees and the Finance Committee, and he and Rubie Butterworth will both work with the Council on Ministeries.

Administrative Board \$405,000 Budget For

The Administrative Board approved a budget for Trinity's program and ministry for 1982 totaling \$405,000, \$10,000 less than the budget proposed by the Board last November.

The formal acceptance of the budget came during a Board meeting January 8 following a stewardship crusade report that showed total pledges and anticipated member contributions of \$336,308. A cash carryover of \$10,026, plate offerings of \$10,000 and \$48,665 income from trusts held by the church, Sunday school offerings, parking lot fees and meal tickets will provide the additional revenue budgeted.

The budget was reduced \$10,000 from the proposed budget as published in the November Tidings. The Administrative Board approved recommendations that \$1,000 be deleted under local missions. The amount had been designated as the District Superintendent's Fund and it was upon his recommendation that the change was

Some \$600 in savings was realized in recent changes in staff personnel, and \$500 was added to the budget to assist in implementation of the new adult ministries program getting underway at Trinity this month.

Also added was \$1,000 for an audit of financial records as required annually by the Methodist Discipline, \$3,500 start-up funds for computerized membership and financial recordkeeping, and about \$3,000 increase for contingencies.

These were balanced by reductions of \$1.500 from 1982 stewardship crusade expenses, \$1,000 from postage, \$500 from cost of an office copying machine, and \$10,200 from repairs and improvements to church buildings. The last item was eliminated because, with the recent creation of the Trinity Hall Modernization Committee, improvements to the buildings will be delayed until that committee completes its report and recommendations sometime next fall.

Stewardship crusade chairpersons Bettye and Tommy Roberts gave the Administrative Board an evaluation of their committee's efforts in raising the budget and made recommendations for methods to be used for the crusade next fall.

"We agree if you involve a great many people as we did on crusade

committees, chances of success are greater," Mrs. Roberts said, "but the crusade should not be just a committee's task-it is a churchwide ef-

She said it is essential members of the church are well informed about program and ministry needs and that their contributions and pledges are needed. She recommended that "we go into the neighborhoods, get to know all the members and let them know they matter all year long.'

Another recommendation was that a chairperson and assistant chairperson be appointed now in order to have more time for the organization required for a successful crusade. Mrs. Roberts said the addition of an assistant chairperson would provide a training experience for someone to move into the chairmanship the following year.

The Stewardship Crusade Committee's efforts resulted in a total of 553 pledges, 29 more than in 1981 and \$45,000 more in the amount pledged. Total pledges came to \$296,471.

The Administrative Board applauded the Robertses for their leadership and for the more than 400 hours of service they contributed during the crusade period. "Not only have you demonstrated a joy in serving your church, you communicated that others," Senior Minister Walter Kalaf summed up.

Kresge Department of Church Music at Scarritt College, the Chamber Singers' repertoire on this year's tour includes renaissance, baroque, and classical works, contemporary songs, and spirituals. Among the choral masterpieces to be performed are Haydn's "Te Deun, Laudamus," A Scarlatti's "Exsultate Deo," G. A. Perti's "Adoramus, Te," Palestrina's "Adoramus, Te," and J. S. Bach's "Praise the Lord, All Ye Nations."

The 16 singers come from ten states and are preparing for careers in church ministry.

Advanced Studies Class Begins Series on Alcohol, Drugs

A series of Sunday school lessons on Alcohol and Other Drugs begins Sunday, February 7, in the Betty Phifer Advanced Studies Class, meeting at 9:45 a.m. in the Conference Room.

Class member Dan Stainer will introduce the series with an esoteric discussion of the problem, using the study book, *Faith Meets Life* prepared by the United Methodist Publishing House, Nashville.

Because almost everyone's life has been or may be touched by someone with an alcohol or other drug problem, all Trinity members are invited to attend the Advanced Studies Class during February to learn about the problem and what help is available in resolving it.

On February 14, Frank Hargadon, a youth counselor specializing in substance abuse, will lead the discussion on "Basic Ideas of Dependence on Alcohol and Other Drugs—Both Physical and Psychological Aspects."

Richard Shepard, also a professional counselor specializing in substance

abuse is scheduled to speak on February 21 about "Chemical Dependence and the Family."

On February 28, Bill Ray, a counselor at Apalachee Mental Health Association, will discuss the problem as it relates to teens and adolescents, either as a user or as a member of a family in which alcohol or drug abuse exists.

"Our greatest failure as a church right now may be our denial of the existence of the alcohol problem. We contribute to the problem when we are not willing to become involved or even to discuss the use and abuse of alcohol."

Board of Trustees Elect 1982 Officers

The Board of Trustees, at their organization meeting on January 4, elected officers to serve for the year 1982.

Ernest Menendez and Kitty Funderburk were re-elected as chairperson and vice-chairperson respectively. Bob Yates was elected as secretary and Palmer Williams was elected as trustee representative on the Finance Committee.

Three of the trustees began a threeyear term as the Class of 1984. They are Margaret Everhart, Melvin Pope, Jr., and Palmer Williams. Bob Yates began a one-year term, replacing Nick Dawirs of the Class of 1982, who found it necessary to withdraw as a trustee due to a schedule conflict.

The other five trustees are Griffith Pugh, Sr., and Ernest Menendez, Class of 1982; and Kitty Funderburk, Lewis Hall and Frank Moor, Class of 1983. The three trustees in the Class of 1981, David Kerns, Tommy Roberts and Gordon Rogers, completed their three-year term on December 31, 1981.

Missional Outreach Helps Scarritt Train Church Musicians, Educators

On March 7 members of Trinity will be visited by singers and the president of one of the national and world mission programs this local church is helping sponsor.

For the first time this year, Trinity will contribute \$1,000 to Scarritt College, a national graduate center for Christian education and church music in Nashville, Tennessee.

Directly related to the General Conference of The United Methodist Church, the institution grants the master of arts degree in Christian education, the master of church music degree, and the master of arts degree in church music education. Persons who seek Christians vocations in the church come to Scarritt for education as professional leaders of ministries to children, youth, and adults.

The Rev. Dr. Walter Kalaf, Trinity's senior minister, is chairman of Scarritt's Board of Trustees, and has invited its president, Dr. Donald Welch, to preach here on March 7. The Scar-

ritt Chambers Singers will sing during the worship services.

Scarritt's role in Methodist higher education has differed across the span of its history. Scarritt has served as a missionary training school, and as a two-year senior college and graduate school, in addition to its current emphasis as a graduate center. Its 5,000 alumni can be found worldwide in a variety of careers.

At Scarritt, students are given the opportunity to explore their best context for ministry. They are challenged to think about the Christian faith and discover fresh possibilities for living it. The college's concern is for ministry in its total application.

The college began in 1892 through the efforts of a group of women who saw the need for religious education for women serving in the mission fields. Scarritt Bible and Training School was established in Kansas City and for 25 years provided education for women in Christian service.

Facing the need for expansion, it found a new home in Nashville in 1924, where it became affiliated with the George Peabody College for Teachers. It was renamed Scarritt College for Christian Workers to reflect its broader purpose and opened its doors to include men.

Today Scarritt College is United Methodism's only institution of higher education focusing upon the vital areas of Christian education and church music.

FSU Opera Department Presents 'Noah's Flood' At Trinity Feb. 21

At Trinity United Methodist Church from 4 to 5 p.m., Sunday, February 21, the Florida State University School of Music will present the musical play, *Noah's Flood* by Benjamin Britten.

The FSU Opera Department directed by Gene Dybdahl and children of Tallahassee will take part. There will be no reserved seating and admission is free.

Noah's Flood is a musical work written by the contemporary English composer, Benjamin Britten. Presented first in England in 1958, it is one of the 10 most performed contemporary operatic works today.

The work is based on a miracle play that was performed in England during the Middle Ages. *Noah's Flood* calls for an intimate situation, preferably in a church, because of the interplay between the audience and the performers.

The story is simple . . . it is the Bible story of Noah, the ark, and the flood.

The orchestra and leading characters will be from Florida State University. A secondary orchestra and Noah's animals will be students and adults from Tallahassee. Art work and production properties will be created by Tallahassee school children.

Wollschlagers to Chair 1982 Bazaar

Georgianna and Lynn Wollschlager have agreed to serve as chairpersons of Trinity's second annual churchwide bazaar next fall.

Bob Bass, who with Jane Love chaired the church's first bazaar on December 5, made the announcement to the Administrative Board during the board's meeting January 19.

He reported that proceeds of approximately \$3,000 resulted from the 1981 event and will provide funding for the HEO program this year.

"The bazaar was a first for most of us," Bass said, "but we had terrific involvement from most of the Sunday school classes and United Methodist Women," Bass said.

Earlier in the month, members of the bazaar's executive committee held an evaluation session to discuss better ways to plan and stage the event. Date for the 1982 bazaar was tentatively set for late October or early November.

Church Women United Hear Speakers on Refugee Problems

Church Women United of Tallahassee recently held a forum on the subject, Refugee Problems.

Craig Mills, member of Presbyterian Mission Board who in 1979 surveyed refugee camps in Southeast Asia and in 1981 surveyed refugee problems and centers in Africa and Europe for Presbyterian Church U.S. and for Church World Service, spoke on world problems of refugees.

He explained that we in the United States tend to think that we have the burden of these problems because in the past we have been able to choose which people and how many entered our shores. The United States is not first on the list as host when one considers numbers of fleeing people or financial aid in support of these peo-

In numbers Canada, which takes in more refugees than any other country, ranks first with one refugee for every 324 citizens. Australia ranks second and U.S. is third with one refugee to every 374 citizens. In financial support per capita U.S. ranks seventh giving \$.74 per citizen against Sweden's rank of first with \$3.34 per

There are more refugees in the Continent of Africa than anywhere else. Many poor countries there accept refugees from neighboring countries and share with them their meager supplies.

Mr. Mills suggests that churches work through National Council of Churches of Christ who work for peace and well-being around the world.

The second speaker in the forum was Dr. Janis Thompson of Tallahassee Interfaith Council, who has written workbooks for adult study and discussion on Haiti and Haitian Refugees and on U.S. Refugee Policy.

Dr. Thompson defined a refugee as one who must move in order to survive. She explained the push-pull influencing his move. Factors like revolution and oppression push while factors attractive to well-being are pull factors. Think of the pull when you know that U.S. has 6% of the world's population but use 40% of the world's goods.

Until 1875, U.S. had no laws for immigration. Are we not all descended from refugees? In 1948 after WWII we refused to accept large numbers of Jewish people. This period is called the "dark page in U.S. history." 20,000 Iewish children were not admitted except by previous quota numbers.

An additional 6% of refugees were admitted in 1965 but by definition they had to be fleeing political pressure from a communistic country or be from the Mid-East.

In 1980 the definition was changed to be a person who could not return to his own country for fear that his life would be threatened. The top limit is 50,000 a year and the President may add to that (must confer first with Congress) if it is for humanitarian reasons. U.S. accepts people fleeing from communism but do not accept Haitians who are most greatly oppressed. President Carter gave special status to Haitians and Cubans but Congress has not acted. After 1980 these people have no status and nothing further has happened.

* * * * * * Speaking from the historical perspective was Dr. Darrell Levi, associate professor of history at FSU. He specializes in Latin American history and teaches a course on the Caribbean. He gave answers to the questhe Caribbean?"

Dr. Levi defined a historian not as a custodian of facts and dates but one who makes better use of facts for the future. For our consideration he made five points:

- 1. The refugees are a symptom of a terrible disease that exists in the Caribbean.
- 2. The land of the Caribbean is fragile. The impact of the environment on the land has destroyed its fertility. Haiti may have been damaged beyond repair by biophysical
- 3. What is the disease referred to? It is popularly called underdevelopment. It is a process Europeans brought to the New World. The main symptoms are poverty and repressive dictatorship. Gross inequality of living standards is the rule.
- 4. Underdevelopment is a chronic disease. With slavery and sugar plantations the economy became regressive. Harold Ickes said that there had never been more exploitation than is Puerto Rico. The lower 10%of the population had $.6\,\%$ of the total wealth and after ten years of "development" by U.S. that 10% of the population now has .4% of the wealth.
- 5. U.S. is the caretaker of the disease. Trujillo was the most repressive of all dictators. The cure of the disease is up to the people of the Caribbean. We should make it more possible for them to cure the disease.

Randy Pendleton is a reporter for the Florida Times Union who made the trip to Haiti with Lieutenant-Governor Wayne Mixon and party to negotiate with the Duvalier government there. He is author of a series of articles in the Times-Union which began November 26.

Mr. Pendleton was skeptical of the results of such a mission. The talk was about improving Haiti's image for tourists rather than improving conditions for the inhabitants. Helping images may be just propping up the government there.

He observed many missionaries there with model farms and communities. While the lives of these few are being improved, the skills necessary to run such a system are not being taught to Haitians.

Haiti imports 50% of its food. The population is increasing by 2% a year. Mr. Pendleton feels that stress of birth control and population control is most important.

Mr. Howard Goeringer is a retired Church of Christ minister. He was director of the Metropolitan Council of Churches in Pennsylvania and helped develop the Ministry of Community Relations in New Jersey. He has worked with the Quakers in a selfhelp housing service primarily for

tion, "Why are there refugees from migrant workers. He has brought together a group called Tallahassee Ecumenical Mission, working with Haitian families here in Tallahassee.

He seeks to put the problem in Biblical perspective and explore the question, "How can churches in Tallahassee become involved in a way that is helpful?"

Mr. Goeringer suggests that God's plan is not to save us one by one in splendid isolation but to unite us in personal love—to invite us to show the kind of justice that brings good news to the poor and release to the cap-

Mr. Goeringer sees God's purpose for refugees in the event of calling Abraham from Ur to the promised land, revealed again taking the Children of Israel out of the land of Egypt. The mark of the faithful is to share bread with the hungry. If we, who have nearly one half of the world's wealth do not embrace them, how can we do justice?

He invites us to start a study group within our church to understand problems of refugees and prayerfully consider our role in helping them.

Charge Conference Approves Incorporation Of Trinity

A Charge Conference, called to order immediately following the meeting of the Administrative Board on January 8, adopted articles of incorporation and bylaws for Trinity United Methodist Church, Inc.

Incorporation papers will be filed in the Corporations Division of the Secretary of State by J. Lewis Hall on behalf of Trinity's Board of Trustees.

Hall, who drew up the corporation articles and bylaws with the assistance of several other lawyer members of the church, explained their purpose to the Charge Conference and detailed authority for maintaining, receiving and transferring property and

The new legal document authorizes a parsonage committee and a finance committee and provides guidelines for amending budgets. It explains the duties of the trustees related to the property of the church and calls for annual reports and inventory.

Hall said the new corporation follows the Methodist Discipline in connection with these requirements.
