**Bishop Deplores Distrust** 

## Florida Annual Conference Elects **Delegates, Votes Out Homosexual Ministers**

In his annual state of the church address to the Florida Annual Conference, United Methodist Bishop Earl G. Hunt, Jr., told 844 lay and 741 clergy delegates the work of the church will never be done while the energies of the church are being spent negatively.

Speaking Monday, May 23, opening night of the weekleng conference in Branscomb Auditorium on the Florida Southern College campus in Lakeland, Bishop Hunt deplored the ecclesiastical distrust that has occupied the church since Readers Digest and CBS's Sixty Minutes made allegations discrediting the work of the National and World Councils of Churches.

"The work of Christian mission has been put on the shelf while we rushed to put out a fire . . . Something needs to be done to get United Methodists to read their own church papers and not believe a hostile press," he said, referring to many letters he has received about the National Council of Churches and the United Methodist involvement in it. He told the conference the United Methodist Council of Bishops is investigating the NCC and will report at a later date.

Bishop Hunt went on record as "opposed to the homosexual lifestyle in and out of the ministry and opposed to heterosexual aberrations, but the church must minister to them."

"Let us be sure the drummer we follow is God and not fall behind bigoted nitpickers," he declared, urging the church to reach the place where racial integration is so normal it is unnoticed.

"Blessed are the peacemakers-Christians have an unmistakable responsibility to complete the church's unfinished business," he said. He lifted up outreach ministries of the church and prevailing prayer that brings grace and power of God into a church, the conference and to persons.

"You measure a church by asking if it spends more on others than it does on itself," Bishop Hunt said, as he expressed regret that the Florida

#### Commissions of Church To Meet June 6

Members of Trinity's commissions on worship, education, missions, church and society, Christian unity and interreligious concerns, evangelism, higher education and campus ministry, and stewardship will meet simultaneously Monday, June 6, to review the program of the church for 1983 and make plans for 1984.

General Conferences Issues, **Delegates** 

In preparation for the General Conference of the United Methodist Church to be held in Baltimore in May 1984, and the Southeastern Jurisdictional Conference next July, the Florida Annual Conference spent a large part of its five-day meeting electing lay and clergy delegates. It required 13 ballots to elect 30 lay delegates to the two conferences and a like number of ballots to elect 30 clergy delegates.

District Superintendent Tom Mitchell and Barbara Mitchell, a member of Trinity, were elected delegates to the Southeastern Jurisdictional Conference. Trinity minister Walter N. Kalaf was elected a reserve delegate to that conference. Only other Tallahasseean elected was Delores Jackson of Killearn United Methodist Church, also to the Jurisdictional Conference.

A resolution to be sent to the General Conference dealing with homosexuality was heavily debated on the first day of the conference in Lakeland. The resolution, endorsed by the Boards of Ordained Ministry of the Southeastern Jurisdiction and the Florida Conference and by the Cabinet of the Florida Conference, was supported by a large majority of the delegates.

The resolutions states:

"While such persons set apart by the church for the ministry of Word, Sacrament and Order are subject to all the frailities of the human condition and pressures of society, they are required to maintain the highest standards represented by the practice of fidelity in marriage and chastity in singleness. Since the practice of homosexuality is incompatible with Christian teaching,

professing and/or practicing homosexuals are not to be accepted as candidates, ordained as ministers, or appointed to serve in The United Methodist Church.'

Other resolutions adopted by the conference concerned racial and religious hatred and the root causes, designated 1984 as the Year of the Christian Family, and sought to amend the Book of Discipline to exhort parents of nonbaptized children, transferring from other churches, to present these children for baptism.

Committees, work areas and agencies of the church reported on accomplishments of the past 12 months and plans for the next church year. The Conference Council on Ministries presented its program and budget for the year, and the Council on Finance and Administration gave a report of \$9,311,551 in expenditures for 1983 and a proposed budget totaling \$10,-193,663 for 1984.

Linda Yates and Allie Ferguson attended the conference as Trinity's lay delegates. Also attending as District delegates were Elise Lawton, Miriam Pierce, May Hamilton, Barbara Mitchell. Ministers Walter Kalaf and Brent Byerman and diaconal minister Gayle Jordan also attended from Trinity.

Mrs. Yates wes elected to the Conference Council on Finance and Administration; F. E. Steinmeyer III to the Conference Legal Advisory Council; and Miriam Pierce to the Committee on Nominations.

# Members Can Help Income Meet Expenses

As the church comes to the aid of her members in times of difficulty, now is the time for Trinity members to come to the aid of their church.

The problem is cash flow. Too little has been coming in for the past two months to meet expenses.

Although during the summer months vacations usually result in a slow down of pledge payments, reductions in financial giving have been noted for the last several months. The weekly *Tidings* reports receipts and amount needed each week to support the church's program and ministry.

The May 15 Tidings showed receipts of \$4,454.75 and weekly income needed as \$8,326.92. The May 22 Weekly Tidings showed receipts of \$4,452.17. Financial Secretary Martha Sponholtz anticipated the deficit of income over expenses to total about \$15,000 by the end of May. She said the church would need \$21,000 to pay expenses and apportionments to the Annual Conference but would only receive from \$6,000 to \$8,000 in contributions from members by the end of the month.

In the meantime, monthly utility bills total as much as \$2,000, payroll and postage expense, conference apportionments and the sanctuary mortgage payments continue to add up.

Those who are behind in paying their current pledge or who are able to make advance payments to forestall this summer's financial crisis are encouraged to do so immediately.

In the fall, Trinity members pay their pledges in a more regular pattern and the church usually ends the year with all obligations paid. This year may also depart from that tradition. The Administrative Board in February adopted a budget for 1983 totaling \$433,000. Pledges and other anticipated income are about \$10,000 short of underwriting that budget.

The 1983 church year began with less cash carryover than in previous years. The budget also anticipated approximately \$6,000 which the Trustees expected to realize from sale of property donated to the church. Trustees have been unable to negotiate a sale.

Peggy Hughes, chairman of the Administrative Board, and Bill Mattice, chairman of the Finance Committee, appealed to members of the Administrative Board in a letter dated April 25 to increase their individual pledges in order to make up the deficit. By May 27, only \$2,402 in additional pledges had been committed.

All Trinity members are asked to review what they have pledged to their church this year and increase that pledge as circumstances and conscience permit. Members who have not pledged are asked to consider making a commitment that will help Trinity's program and ministry to continue without interruption.

# Adult Fellowship Plans Trip to Ozarks

Reservations for the fall trip by the Adult Fellowship are due in just a few weeks. Those who would like a nine-day trip through the Ozark region of Arkansas October 18-26 should make a deposit by July 1.

An exciting, fun-filled trip is planned to include Vicksburg, Mississippi, Hot Springs, Eureka Springs, the Pine Mountain Jamboree, Elna Smith Foundations, Passion Play, drama of the "Shepherd of the Hills," Silver Dollar City, Foggy River Boys, cruise on the "Zebulon Pike," School of the Ozarks, Presley's Mountain Jubilee, and Malone's Catfish House in Tupelo, Mississippi.

# Trinity Blood Bank Account Needs Replenishing

Trinity has an account at the Leon County Blood Bank for use by members and their families. For the past few years the Trinity family has been using more pints of blood from the account than has been replaced.

In January 1981, Trinity had 23 pints of blood to her credit. Today the church has only six. Below is a record of the account:

For blood to be used from the Trinity account, a credit transfer request must be submitted from the church office to the Leon County Blood Bank. This request authorizes the Blood Bank to transfer credits of blood from the Trinity account to the account of the Trinity user at the designated hospital. Dr. Walter Kalaf, Mrs. Rubie Butterworth, Mrs. Jana Melton or Mrs. Charlotte Bozeman can make this credit transfer request.

Blood is something none of us really plans to replace, but when needed, it is a gift of life. Since our account is dwindling, we urgently need to increase it in the next few weeks. Our goal is to have 12 donations by the end of July and to have a balance of 25 credits by the end of December.

Remember that some credits may be used during the year so that more than 19 donations would be needed to total 25 credits by the end of December. You may want to make this a project of your group in the church.

Next you ask yourself, "Am I eligible to donate?" Probably so, if you answer "Yes" to the following questions:

- Have you had your 17th birthday? OR
- If you have also had your 65th birthday and are in good health, have you donated blood before?
  - Have you been in good health

for the past few weeks (no colds, diarrhea, sore throats)?

- Is your blood pressure under control (with or without medication)?
- Has at least one week lapsed since you completed antibiotics to treat an infection and the infection has
  - Do you weigh over 100 pounds?
- If you have donated before, has it been at least eight weeks since you last donated blood?

If you answered "Yes" to the above questions then *YOU* need to be a volunteer blood donor for Trinity. Please go to the Leon County Blood Bank at 1240 Hodges Drive. Hours are Monday through Friday, 7 a.m. to 6:30 p.m.

If this is your first time to donate blood, the following information might be helpful:

- Tell them you are donating for Trinity United Methodist Church.
- Allow 40-50 minutes to answer questions and donate. They are very thorough on the initial screening.
- Be sure you have eaten a meal prior to donating. If you plan to donate in the morning, eat breakfast before you go. If you usually don't eat breakfast, then plan to donate after lunch.
- For the remainder of the day you donate, plan to drink plenty of fluids, eat a good meal and keep your activities relatively quiet (no strenuous exercise such as softball).
- Resume normal activities the day after you donate.
- It has been estimated that there are 8 pints of blood per 100 pounds of body weight. Florida law allows you to give only one pint of blood no more frequently than every 8 weeks. (That means that if you donate now, you can donate again before the year is out!)

# United Methodist Church Begins to Grow

The United Methodist Church in Florida is beginning to grow, the Work Area on Evangelism reported to clergy and lay delegates at the Annual Conference of the UMC in Lakeland May 23-25.

Good Shepherd United Metthodist Church, West Palm Beach, was saluted for leading the conference in the number of new members by professions of faith—173—and Bartley Temple, Eustis, was honored for the highest ratio of professions of faith to membership—38.7%.

Trinity United Methodist Church was fourth among churches in the Tallahassee District with 17 new members by professions of faith. Pine Grove had 35, St. Paul, 30, Killearn and Lake Jackson, each 26.

About one-fourth of Florida United Methodist Churches did not receive one new member by profession of faith in 1982. The Work Area on Evangelism congratulated the churches which recorded professions of faith among their net gain for "leading the way in sharing God's love and plan with their friends, neighbors and associates."

Total membership growth in all Florida Methodist churches in 1982 was 2,568 or 0.8%. Conference membership is now 334,773. Districts showing the greatest gains were Sarasota, Melbourne, Gainesville and Tampa.

On an average Sunday in 1982, 144,091 United Methodists attended worship services, up 2.5% from 1981. St. Paul of Largo had the highest number at worship with 1,652, and Pasadena at St. Petersburg, where former Trinity minister Ed Norman preaches, was second with an average worship attendance of 1,522.

Conference church school membership totals 117,562, a 924 gain over 1981. Highest church school attendance was at First in Lakeland with 959, and at Trinity in Gainesville with 807. Church school attendance is up 0.1% for a conference-wide average of 62,459.

Trinity of Tallahassee was among the top 25 churches in the conference in giving to general and conference advance specials. Trinity's gifts for this purpose totaled \$14,177 in 1982.

# The Styrofoam Cup

For years the Betty Phifer Advanced Studies Class has given offerings each Sunday in two ways. In the "plate" we put the regular Sunday School offering. In a white styrofoam cup we put money for special projects. We try to match the amounts, but we don't have any accurate accounting.

The special projects over the years have included the Terrell House and a number of other good agencies serving human needs in our community. The cup also symbolizes (in addition to money) the giving of ourselves in other ways—through food, clothing, services, and efforts to promote worthwhile causes. Giving has been considerable, but not enough.

To be a significant force in meeting human needs, we must give more to others. The list of "others" seems endless. A sort of "laundry list" would include many worthwhile community-based efforts, some of which our churches, local taxes, and the United Way partially support. We also give to others statewide, nationwide, and worldwide through agencies serving human needs. But we do not give enough.

Part of our hesitation, particularly when we give through agencies supporting human needs and causes nationwide and worldwide, is our concern that our gifts may not actually reach the human recipients with a minimum of overhead costs for administration, personnel, and the like. In other words, we all seek assurances that what we give reaches those for whom it is intended. Assurances are not always convincing, and we are continually plagued by the suspicion that too much of our giving may be consumed before it reaches people. We worry that gifts may hurt, rather than help people in the long run—that we are contributing to "band-aids" when more permanent constructive help is needed. Our hesitation may, however, be a convenient excuse for doing very little.

Of all the ways to help human needs, our church is, or should be, our most effective avenue. Church programs serve our own congregations well and with less overhead cost than most agencies. When it comes to human needs in the community, state, nation, and world, church members often designate half of the income from offerings and pledges to help others. If we do not do this yet, there is hope that we shall make it our goal.

In our church budgets we do allocate a portion to help others. Our support, by providing our facilities and leadership, is considerable. We are striving to make ourselves more than a Sunday church or Sunday school, and are involved in a week-long and all-year love affair to help others in the name of God.

On the national and world scene, our missions do good things to help others, and a pitifully small, but important, portion of our budget is given for others through the National and World Council of Churches.

These recently criticized bodies (NCCC and WCCC) have a good record. They do good things for those who need it. Help reaches people directly through ecumenical efforts and with a minimum of administrative costs. This help does not induce undue dependency, but rather contributes to long-range efforts to move recipients from receiving to self-sustaining, and eventually to the "giving" categories. Because the National and World Councils are so concerned with the root cause of hunger and poverty they become rightly involved in seeking solutions that avoid "band-aid" approaches. Although some such efforts have been criticized in Readers Digest articles and on Sixty Minutes, the National Council does not fund or otherwise support communist governments or movements anywhere in the world. Neither do the Councils withhold help from people who are unfortunate enough to live under communist or other repressive governments (which may give rise to some of the misguided criticism). Help to people through the Councils is given as directly as possible and not through their governments. The biggest criticism that could be made of the National and World Council of Churches is that they do not do enough, and that is because we do not give enough.

The 50-year history of devoting increasing portions of our federal government taxes "to promote the general welfare" is being reversed in favor of leaving this to the states or private giving. Whether we approve of this or not, it seems doubtful that the states or private giving will make up the difference, unless citizens assume more responsibility. The church is one agency that might help to pick up this responsibility.

If our national policy continues to be to increase the portion of our taxes "to provide for the common defense" and to decrease the portion "to promote the general welfare" it becomes our individual responsibility to help restore some balance. If we cannot influence government to do this, we must do it ourselves until and beyond the day when world peace is assured.
