Pre-Lenten Ecumenical Lecture Series Begins February 5 at Trinity United Methodist

Dr. Roger L. Shinn, Reinhold Niebuhr Professor of Social Ethics at Union Theological Seminary in New York City, will deliver the keynote address Sunday, February 5, to begin the second annual Pre-Lenten Ecumenical Lecture Series in Trinity's Fellowship Hall. Lectures will be given each Sunday night in February, sponsored by nine Tallahassee churches.

Speaking on the general theme of the series, "Living the Faith in the Modern World," Dr. Shinn will speak at 7:45 p.m. and answer questions from the audience from 8:30 to 9 p.m.

Administrative Board Adopts 1974 Budget; More Pledges Needed

The \$460,000 operating budget the Administrative Board tentatively adopted last October was formally ratified at the board's meeting on January 23.

Finance Committee Chairman William Mattice told board members the budget contains no needless expenses. "It is as tight a budget as we can put together," he explained.

John Olson, chairman of the stewardship crusade that sought to underwrite budgetary needs with pledges, reported to the Administrative Board that the crusade is just \$25,000 short of reaching its goal.

"I am confident the needed pledges are out there. I am distressed that there are a tremendous number of members who have not been properly challenged to broaden their base of giving," Olson said. He plans to continue to serve until the necessary pledges are obtained, he told the board.

Olson said he will recommend to the Finance Committee that a policy be adopted to automatically continue member pledges so that the Stewardship Committee will not have to start the entire process each year. Members will have the option to decrease, increase or discontinue a pledge at any time.

The 1984 budget is \$27,000 more than 1983's \$433,000 anticipated needs. The year ended with \$423,365.78 of that amount being spent.

Trinity's share of apportionments assigned to it by the Florida Annual Conference was increased to \$75,796 in 1984, up from \$67,562 in 1983. Local missions are also increased from \$4,400 in 1983 to \$10,860 in 1984—\$5,410 of this amount for the radio ministry formerly paid by special gifts. National and world missions total \$6,511 in the new budget.

Staff and ministerial salaries and benefits account for the largest share of the budget—\$204,090. Most salaries remain the same as in 1983.

Administrative costs such as postage, telephone and computer service will be about the same, as will property expenses such as repairs, utilities and building debts.

The detailed 1984 proposed budget was published in the November 1983 *Monthly Tidings.*

A coffee hour precedes the lecture at 7:15.

Dr. Shinn's earlier academic posts were at Heidelberg College, where he was professor of philosophy, and Vanderbilt University, where he was professor of theology. He received his undergraduate training at Heidelberg, his seminary training at Union, and his doctoral training at Columbia University.

He is a noted writer and lecturer on international peace, economic justice, criminal justice reform, environmental issues, politics, and business ethics. In addition to his frequent articles in such periodicals as *Christianity and Crisis* and *The Christian Century*, he has produced numerous books, the most recent of which is the widely quoted *FORCED OPTIONS*: Social Decisions for the 21st Century (Harper and Row). Dr. Shinn is an ordained minister of the United Church of Christ.

Mary Cosby will deliver the second lecture February 12 on the topic, "The Inner Life of Faith."

Three To Interpret UM Mission Outreach During Mission Awareness Weekend Feb. 11-12

Three mission leaders serving the United Methodist Church will be at Trinity the weekend of February 11-12 to broaden members' understanding of the church's participation in mission outreach on a global scale.

Seventeen other mission interpreters will be in United Methodist Churches elsewhere in the Tallahassee District as part of a Mission Awareness Weekend.

Carrying out the theme, "The World Is My Parish," the mission interpreters are bringing with them pictures, slides, stories, illustrations and first-hand accounts of what it is like to be in mission today. Visiting speakers at Trinity will concentrate on mission work in African countries.

Trinity's Commission on Missions will begin the weekend with a coffee for the general membership of the church in the Fellowship Hall on Saturday, February 11, from 10 to 11:30 a.m. Retired United Methodist Bishop Ralph E. Dodge of Dowling Park will speak on the church in Africa where he spent more than 30 years as a missionary.

On Sunday morning, February 11,

Liberia and Christian education in that nation will be discussed by Eleanor Hankins, now a guidance counselor for the Duval School System in Jacksonville. She and her husband served as missionaries in Liberia for several years. While there she specialized in Christian education and trained teams of youths to conduct vacation Bible schools. James H. Hankins is now pastor of Hendricks Memorial UMC in Jacksonville.

Trinity's adult Sunday school classes will meet together at 9:45 a.m. in the Fellowship Hall to hear Mrs. Hankins.

Children and youth of Trinity will have a creative festival of African arts later that day as Jim and Eleanor Hankins interpret mission work in Liberia to them. Grades 3-5 will meet at 5 p.m. for the children's enrichment program. Members of United Methodist Youth Fellowship will hear the Hankins during their regular Sunday session at 6:30 p.m.

The Commission on Missions will complete this churchwide mission study of Africa with a church family night program on March 4. Speaker for that program will be announced.

Mrs. Cosby is a founding member and the wife of the pastor of The Church of the Savior, Washington, D.C., a unique, small, nondenominational, interracial church which requires a rigorous preliminary course of Christian studies for all potential members. The church owns "Dayspring," a 200-acre retreat center near Washington, D.C., which is available to all, and maintains "The Potter's House," a coffee house ministry in downtown Washington.

Mrs. Cosby received her formal education from Randolph-Macon Woman's College and American University. She is known internationally as a lecturer on spiritual growth and commitment to discipleship.

Frank A. Butler, a registered professional engineer and an Episcopal lay leader from Topsfield, Massachusetts, will deliver the third lecture February 19. His topic will be "Living the Faith on the Job."

Butler is president and general manager of Eastman Gelatine Corporation, a subsidiary of Eastman Kodak Company, and is a member of the American Institute of Chemical Engineers. He is a graduate of the University of Maine, a ventryman of Trinity Episcopal Church, president of the North Shore Economic Council, chairman of Home Prayers, and vice president of the Evangelistic Association of New England. He is a member of the board of directors of a number of business, civic and church agencies, and is a trustee of Gordon College.

The final lecture in the annual Pre-Lenten Ecumenical Lecture Series will be given February 26 by Dr. Yvonne Delk, executive director for the Office of Church and Society, an instrumentality established by the United Church of Christ. Its mandate is to study the gospel in its bearing on people in society, provide and publish information on social issues, cooperate with the United Church of Christ and other ecumenical bodies in making the implications of the gospel effective in society, and formulate and promote a program of social education and action for the United Church of Christ.

Dr. Delk is the first black woman to achieve executive office in the United Church of Christ. Her topic will be "Society's Challenge to the Christian."

A registration fee of \$5 per person for the series may be paid at the door. Registration fee for students and spouses of students is \$2. per person.

The Church That Gives Lives

The slogan that heads this editorial was used during the Trinity Hall Fund/ Florida Conference Fund Crusade in February and March 1983. The above prayer was mailed to all members of the church as the crusade began.

If we study the financial report of Trinity for 1983 that appears on page 3, we know that the congregation responded with a generous commitment to strengthen God's work at Trinity and through Trinity.

 The Trinity Hall Fund was underwritten with pledges of \$542,625. The fund received payments totaling \$211,000 during 1983.

• The Florida Conference Fund received pledges of \$35,603 to help establish a loan fund to build churches and expand Methodism in this state. Payments on these pledges totaled \$14,114 during 1983.

• Trinity members gave \$429,730 to the church's operating and program budget during 1983.

• Trinity members gave \$11,597 in extra offerings for designated uses, such as United Methodist Committee for Overseas Relief, United Methodist Children's Home and other benevolences.

Although the year began and entered its 12th month with a deficit budget, Trinity members, through special Christmas offerings and second mile giving, made it possible for the church to cover all expenditures for the year and pay the Annual Conference 100 percent of its apportionments.

It was a year full of great risks, great faith, and great people. The Trinity Hall Modernization Committee made ambitious plans to bring life back to a decaying building, the Fund Crusade Committee accepted the challenge of raising money to finance the renovation, the Finance and Stewardship Committees worked year-long to balance the operating budget, and countless volunteers visited, telephoned, stuffed envelopes and prepared material in support of the committees' goals.

During a recent worship service Senior Minister Walter N. Kalaf celebrated the victory by thanking the congregation for their generous financial support. The congregation in turn owes a great debt of appreciation to Dr. Kalaf for his inspired and tireless leadership during the crucial year of 1983 when Trinity might have receded further into decline but instead embraced 1984 and the future with the assurance that Trinity will be faithful to its mission.



Trinity Members Are Urged to Contribute Gift of Life: Blood

One of every 80 members of Trinity will need a blood transfusion this year, the Leon County Blood Bank estimates: Although the church began 1984 with 21 pints of blood in its account, more donors are needed to maintain a ready supply for emergencies within the Trinity family, Miriam McLarty says.

As coordinator of Trinity's blood bank account, Mrs. McLarty expressed appreciation to the eight to ten members who contribute on a regular basis and to numerous others who gave at least one pint in 1983.

"In 1983 Trinity members donated 26 pints of blood and used 25 pints. I



hope many more members will give the gift of life," Mrs. McLarty said.

The Leon County Blood Bank supplies more than 10,000 pints a year to people in the Big Bend Area. A nonprofit organization, it serves both Tallahassee hospitals and six other hospitals in the surrounding tencounty area.

The average transfusion involves 3.4 pints of blood; therefore, it requires 4 blood donations to treat the average patient. Fewer than 5 percent of eligible people actually donate blood.

Any healthy person, aged 17 or older, can donate blood. It is painless and there are no lasting effects. The actual donation process takes about 10 minutes. The Leon County Blood Bank will answer further questions about eligibility if you telephone 877-7181. Its hours are Monday through Thursday from 7:30 a.m. to 7 p.m. and Fridays from 7:30 a.m. until 4:30 p.m.

The blood bank is located at 1240 Hodges Drive.

Members Give \$676,157

1983 Ends With Apportionments, Expenses Paid, Attendance on Increase

The Administrative Board celebrated Trinity and its people for completing 1983 with a balanced budget, its Conference apportionments paid in full, its staffing complete and its program and ministry revitalization well on its way.

At the first meeting of 1984 on January 23, Administrative Board Chairperson Peggy Hughes led board members in the singing of the Doxology to thank God for the past year's successes.

She then led the board in a special tribute to Senior Minister Walter N. Kalaf for his leadership and good management in guiding to successful completion a year that began with risks.

"We started 1983 knowing we had to take risks," Dr. Kalaf responded. "We knew we had to expand the staff in order to develop the kind of programs we needed, and this was the year to do it. The outcome was unknown but we began by thinking it was the right thing to do," he said.

"It has been exciting to be part of something that worked so well. I thank all members of Trinity for their efforts, their prayers and support."

Treasurer Bill Smith reported to the Administrative Board that the year ended with a carryover of \$6,365. "I am happy to bring you this good news, since so many times during the past year I have had to report a deficit budget to you," Smith said.

The 1983 budget of \$433,000 was undersubscribed by pledges and other income by \$9,667 and in the fall months weekly expenditures frequently exceeded income.

The Finance Committee, Stewardship Crusade workers, Dr. Kalaf and other church leaders continued efforts to bring in more pledges and special gifts. During December Christmas offerings of \$4,935 and extra mile gifts totaling \$15,613 made it possible to pay 100 percent of conference apportionments and other expenses.

Expenses in the operating budget were also reduced so that the year ended with \$423,365 of the \$433,000 budget being spent.

In all, during 1983 Trinity members contributed \$676,157 toward the work of Methodism. Besides the \$429,730 they gave in support of Trinity's 1983 operating budget, they contributed

\$211,000 to the Trinity Hall Fund, \$14,114 to the Conference Development Fund and \$11,597 to designated ministries of the United Methodist Church.

United Methodist Women gave \$3,028 for local and community work and \$6,688 to the District and Conference treasurers for mission work.

The amount given for Conference apportionments, designated gifts and other special goals is detailed below.

In a report to the Annual Conference last month statistics gave evidence that Trinity's program and ministry also increased during 1983.

The report also showed that expenses for the programs of the church totaled \$61,303 in 1983 and \$46,803 in 1982. Other operating expenses were \$176,611 in 1983 and \$147,163 in 1982.

On February 26 Trinity's Youth Choir will sing with the choir at the Wesley Foundation in a cantata entitled "A Reason to Rejoice!"



Looking toward the 1984 legislative session

Editor's note: The following article was written by Karen Woodall, director of Florida IMPACT (a legislative network), and was printed in the December Florida Council of Churches newsletter. IMPACT is partially funded by the Florida Conference United Methodist Church, Work Area on Church and

The wheels of the 1984 Legislative Session have already begun to turn, and committees have begun to address

On November 7 the Policy Board of Florida IMPACT met in Orlando to set its priorities for 1984. The following state issues will receive primary attention.

-Reform of Florida's Election Code to allow for absentee registration and to provide for uniformity in provisions for supporting deputy registrars and branch sites for voter registration.

-Support for expansion of Medicaid coverage and access to health care for low-income people.

-Support for paying 100% (as opposed

to the current 50%) of the standard of need for recipients of the Aid to Families with Dependent Children Program.

-Support for alternative tax resources, i.e., closing existing exemptions for business special interests, etc.

-Opposition to Proposition I or the "Citizen's Choice Amendment."

-Support for efforts to clean up Florida's use of pesticides like E.D.B. and Temik.

-Abolishment of the Crew Chief System in farm labor and strengthening is existing laws.

-Support for a 72-hour cooling-off period before handguns can be purchased.

-Opposition to efforts to establish casino gambling and/or a state lottery.

-Support for making a jury's recommendations of a life sentence binding (at present a judge can override a jury's recommendation).

-Support for licensing of residential child care families, including religious facilities.

These are issues which Florida IMPACT will be focusing on in the Legislature. Substantive information will be forthcoming.

Your voice is needed in the legislative process. If you are not a member of IMPACT, you can join by sending a check for \$20 to: National IMPACT, 110 Maryland Avenue N.E., Washington, D.C., 20002. (This will automatically make you a member of Florida IMPACT).

You will then receive information on state and national priorities, and you will become a part of the phone network for action alerts in your area.
