Bishop Hunt Challenges Florida UM Churches 'To Transform Lives'

Mainline Protestantism, perhaps the most formidable force in molding contemporary America, currently is threshing about in the quagmire of bewilderment, Bishop Earl G. Hunt, Ir., told delegates at the Annual Conference of the United Methodist Church in Lakeland May 26-30.

His state of the church address during the opening worship service in Branscomb Auditorium at Florida Southern College outlined the problems of the church against the backdrop of "this strange and weird day." He said part of the confusion of the church today was born of its inability to understand fully the world in which it serves and its often uncritical capitulation to certain inadequate theological and biblical perspectives that have roamed the religious scene for half a century.

"The most basic cause for confusion in the church today is a low doctrine of the Bible," Bishop Hunt said, adding that he is neither a biblical liberalist nor a fundamentalist in his own religious convictions. To have a high doctrine of the Scriptures does not mean, he said, that one must resist or negate, modern scholarship, but that their fundamental teachings are not be to disregarded or rationalized

"No wonder the church is confused -no wonder our sermons so often lack a ring of authority. Dare I say to all of us that the pulpit of the modern church needs once more to sound forth in attitude as well as words the 'thus saith the Lord' which was always its magnificent credential in other days," the Bishop said.

'The church must seek first and foremost to bring the individual into saving confrontation with the Lord Jesus Christ, and then, through that

transformed individual, make its witness to a world that is sick with sin and tragically stricken with oppression and inequity.

Turning to problems within the Florida Annual Conference, Bishop Hunt alluded to difficulties in the consultation process ordered by the General Conference to help improve the deploying of ministers to local churches. He listed the 11 steps of the process during which the Bishop and his cabinet of district superintendents confer with ministers and staff/parish relations committees in an attempt to make appointments suitable for all.

He emphasized that absolute confidentiality is required of the pastor and the church during the consultation process since every appointment is tentative until all appointments have been made.

Bishop Hunt challenged the conference to do what is necessary to return it to financial solvency through changing the church's pattern of giving, to honor the commitments pledged to Church Development Fi-

nancial Campaign-more than \$8 million for the construction of new churches-and to work to eliminate racism, the threat of thermonuclear war, and pornography.

Membership growth of the United Methodist Church in Florida drew Bishop Hunt's strongest appeal. He expressed bewilderment over the fact that the net membership gain in 1984 was only 230 while the conference had set a goal of 10,000 new members. The conference received 5,326 more members by transfer than it lost in the same process last year, but churches purged their roles, through charge conference action, of almost as many people as they received by profession of faith during the past five years.

"I challenge each of us, beginning with myself, to think and pray about the problem in the Florida Conference and to strive as never before to share the faith with others until the story of United Methodist in Florida becomes resplendent with the drama of saved souls and transformed lives," he said.

The Christian home was Bishop Hunt's final call for church action. He said he is disturbed about the health of the institution of marriage in the parsonage and also in the home of the average church member.

He suggested the following ways the church may become constructively and creatively involved in curing the crisis in marriage:

• The church must accept the good things implicit in the sexual revolution, rather than present puritanical

 The church must know, understand and disseminate the sacred and theological meanings of marriage and its related themes.

• The church must insist upon basic biblical standards where sexual and marital relations are concerned.

• The church must define defensible Christian positions on birth control, abortion, artificial insemination, homosexuality, divorce, racially mixed marriages, genetic engineering, etc.

• The church must become more skilled in teaching youth and young adults about sex, marriage and the family.

• The church must offer healing love, forgiveness and hope to all who have lost their way in modern life.

 Through pastoral concern and ministry, the church must help families confront and solve problems of childlessness, children with congenital handicaps, retardation, teenage marriage, infidelity, chronic illness, grief, marital discord, etc.

• The church must magnify and interpret the great occasions of life such as marriage, birth, baptism, confirmation and death.

• The church must arrange for all family members, especially youth, to have the kind of spiritual encounter with God which remains at the heart of the Wesleyan interpretation of religion.

Conference Recognizes Trinity-

Trinity United Methodist Church received an Evangelism Award during Annual Conference in Lakeland May 27 for the number of members received by profession of faith among churches in the Tallahassee District during 1984.

Tied for the recognition with Killearn United Methodist Church, Trinity's pastors, diaconal minister and lay delegates received a certificate from Bishop Earl G. Hunt, Jr. Both churches received 28 members by profession of faith last year. St. Paul's was close behind with 24.

Top churches in each of the other 13 districts also received certificates. Pine Castle in the Orlando District with 227 new members by profession of faith, Good Shepherd in the West Palm Beach District with 119, Englewood in the Sarasota District with 105, and Community Church in Casselberry with 107, had the highest numerical gain by profession of faith.

The Conference Commission on Evangelism pointed out that across America the United Methodist loss in membership is mostly due to the lack of receiving new persons by profession of faith and our lack of intentionality in helping others to become a part of our fellowship. Last year almost one-fourth of Florida United Methodist Churches did not receive one person by profession of faith.

More than 9,000 persons were dropped from Florida church rolls last year by Charge Conference action, causing the Florida Annual Conference to have a net gain of only 230 members. Although churches in the Tallahassee District had 269 members join their congregations, the net gain was only three.

Tallahassee District churches reported 14,578 members on their rolls and an average attendance of 5,332 or 36.6 percent. Sunday school enrollment totals 6,051 with 50.6 average attendance in the district.

Trinity is the ninth largest church in Florida with 2,458 members. Largest congregation is First Church in Orlando with 4,350 members, followed by First in Lakeland, Community in Pasadena, First in Coral Gables, St. Paul in Largo, Pine Castle, First in Clearwater, and Christ in Fort Lauderdale.

United Methodist Volunteers in Mission To Go To Haiti

Each year the Tallahassee District sends up to three teams of United Methodist Volunteers in Mission to the Caribbean. These are, for the most part, lay men and women who go with little more than open hearts, a willingness to serve and enthusiasm for the Gospel of Jesus Christ.

The mission teams usually include some to teach a week-long Bible school for children, someone to teach sewing, a medical doctor and/or dentist and workers in building and construction. Beyond these responsibilities, team workers have plenty of opportunity to fellowship with Haitian Christians. The Church in Haiti is always demonstrably uplifted by the witness and love of American Christians.

For the first time in several years, Trinity UMC will be represented in this ministry. The Rev. John Quigley will accompany the first VIM team scheduled for August 3-10. Church members may help support him and the district program as well by providing funds and simple items that Haitians need.

Needed are school and sewing ma-

terials and children's clothes. These include needles, thread, fabric, boxer shorts for children, shirts for children, notebook paper, construction paper, ley says there is "one other and even erasers, pencils, crayons, pens.

All items must be new in order to pass through Haitian Customs. They must be carried in the suitcases of the team so should not be bulky items. Cash donations are welcome and will be used to support VIM representa-

tives from small membership churches in the district.

Commission On Missions Visits St. Eugene

Members of Trinity's Commission on Missions met with the Rev. Fletcher J. Bryant, director of religious activities, United Methodist Ministries, FAMU, at St. Eugene Chapel on Tuesday evening, May 2.

The purpose of the meeting was to explore ways Trinity can participate in the 1985-88 quadrennium missional priority of "Developing and Strengthening the Ethnic Minority Local Church: For Witness and Mission."

St. Eugene Chapel is the United Methodist ethnic minority ministry in this area, and it provides a unique opportunity for Trinity to participate in an ethnic minority program of the United Methodist Church.

The chapel is a lovely facility adjacent to the FAMU campus, owned and maintained by the Roman Catholic Church. Father Guy Wilson of St. Thomas More conducts Catholic services at the chapel while Rev. Bryant directs Protestant activities, the two serving jointly as ministers in residence.

About 50 single-parent families live in low cost housing across the street from the chapel with an associated population of over 100 children. The parents, supported mainly by government grants, are enrolled at FAMU in an attempt to upgrade their skills so they can enter the job market. The parent is often so busy with school work that the children are unsupervised. In addition, the grant checks are usually minimal and are often late, leaving the families without adequate food.

Rev. Bryant has been involving these children in church-related activities at the chapel to constructively occupy some of their time, to provide them with religious instruction and even to provide a limited amount of food, usually in the form of occasional church suppers or snacks at church activities. He would like to continue and expand these activities to include a pantry to provide emergency food to the families when the need arises, such as when grant checks are late.

In carrying out its program to the students, their children and the surrounding community, the ministry at St. Eugene runs desperately short of funds. Contributions to this program would be a very effective way for Trinity to contribute to the General Conference missional priority of strengthening the "Ethnic Minority Local Church" since the need is real, the facilities and program are in place for carrying it out, and none of the contributions would be needed for the facility or salaries.

In response to their more present need, the commission is directing 15% or \$375 of the Pentecost offering to assist in establishing an emergency food closet. We are also requesting church school literature and program materials to help in the children's ministry. Rev. Bryant must make copies of what is available at the present time. If you would be interested in participating in the mission program at St. Eugene Chapel, please contact Rubie Butterworth.

Cary Moon Begins Study of Church Music at Scarritt Graduate School

Trinity and Tallahassee will lose a creative musician and composer and a skilled oboist when Cary and Peggy Moon move to Nashville this fall for study in the church music program at Scarritt Graduate School.

Cary was born in Tallahassee and baptized at Trinity. He grew up in the youth program and has served his church in many roles. In the summer of 1983, for example, he helped Miki Harrison with music camp and during the last year he and his wife worked with the senior high Sunday school class.

Graduating from the Florida High music program headed by Glen Heinlen, he studied at FSU before going to Huntington College in Montgomery for his junior-senior study of music theory. Additional study brought him back to FSU where he met and courted his wife, Peggy.

St. Paul's presentation of Godspell enlisted his service as accompanist; he was rehearsal pianist and music director (in effect if not in title) for the Junior Woman's Club production of "Cause for Applause." His service to Methodism includes a term as youth coordinator for the Tallahassee District. And for the last year he has taught both guitar and synthesizer (that modern computer miracle) at the Martha Stubbs' School of Music.

Peggy, Cary's wife of three and a half years, works as a secretary at Health and Rehabilitative Services (HRS), in Tallahassee. She plays oboe and has a bachelor's and master's

degree with specialization in that instrument from the University of Georgia. Both she and Cary have advanced study of music theory at FSU. Her talents have contributed much to Trinity's music program and she has assisted with workshops at (among other places) Stetson University. Her home is in South Georgia; their marriage took place in her home church. Peggy's heritage is Presbyterian; she is Methodist by marriage.

Cary's father served as principal at Woodville, Chaires, and Ruediger. His mother started music lessons when he was five and he promptly played his mother's lessons by ear. He has always been creative, naming his own strengths as spontaneity and flexibility. His weakness? Discipline, he confesses, which Peggy furnishes in abundance. He believes that in our society "creative force needs to be cultivated. Our society does not always appreciate this." He has composed a number of religious songs, both words and music. His brothers are both musical, one on guitar and

the other on banjo.

Scarritt Graduate School offers two graduate programs. One, with about 100 students, is in Christian education; Gayle Jordan is a graduate of that program. The other is much smaller, with perhaps 35 or 40 students in a two-year program for church music. That is the course of study Cary Moon plans to enter this fall. After intensive campus study during the first year, he will work in local church music in the Nashville area for the second year while participating in classes and seminars on the Scarritt campus.

Nashville is for many the music capital of the United States, particularly in country/western music. Cary

looks forward both to working in this atmosphere and in Nashville, a major Methodist center. Across one street from Scarritt is the General Board of Discipleship, and across another street is The General Board of Higher Education and Ministry. Downtown the Methodist Publishing House prepares and distributes both books and Sunday school materials. Scarritt is part of a university complex including Vanderbilt and George Peabody.

Cary loves Tallahassee but thinks that following graduation the chances of his coming home again are rather slim. He is convinced, however, that he will go where God calls him, that he has a "lasting commitment to church music."

Trinity Starts Scholarship Fund

Under the 1984 chairmanship of Myron Blee, Trinity's Commission on Higher Education and Campus Ministry initiated a scholarship fund to help support Trinity's young men and women planning to enter a full-time vocation of church ministry. The ministerial scholarship fund has been approved by the Council on Ministries and the Administrative Board. This fund has until now been unpublicized and supported primarily by personal

contributions from members of the commission. In beginning the fund the commission had for its objective an endowed fund under the sponsorship of Trinity to offer financial assistance to ministerial students. In their thinking, this included those preparing (like Gayle Jordan) for the ministry of Christian education or Cary Moon, preparing for the music ministry of the church (both diaconal ministry careers), as

preparing for the ordained ministry.

The fund now totals about \$500 and is obviously in its infancy. The commission hopes that it will grow into a substantial fund, that it will be invested in the same way Trinity invests other funds entrusted to it, and that the interest from the fund might help and encourage Trinity's youth embarking on training for a full-time church vocation.

Myron Blee and Hal Lewis are working with a small committee to draw up ground rules for the fund and its administration. Anyone wishing to contribute to the scholarship fund may make checks payable to Trinity and designate them for this purpose.

Now that Cary Moon, a son of Trinity, is entering Scarritt Graduate School to prepare for music ministry in the local church the commission hopes that this fund will become large enough in the near future to assist him. As Cary's need is immediate, however, if you wish your contribution to assist him during the up-coming academic year rather than be part of the scholarship fund principal, you may so designate your gift by writing "Cary Moon Scholarship" on your check.

Annual Conference Adopts Resolutions

The Annual Conference of the United Methodist Church, meeting May 26-30 in Lakeland, adopted resolutions supporting causes ranging from the interests of farmworkers to peacemaking and opposing causes ranging from apartheid to violent and destructive acts. The resolutions that summarized below:

Stewardship: It was resolved that the Annual Conference charge United Methodist seminaries to include instruction in stewardship and finance as a requirement for completing a theological education leading to a master of divinity degree beginning with the fall term of 1987. The support of God's work through the local church and the general church is dependent upon the pastor's knowledge of stewardship and finance.

Farm Workers' Week: Due to the plight of the farm workers in the economic system, the lack of awareness, understanding and knowledge of farm workers' issues, it was resolved that the week of April 29-May 5, 1986, be observed as Farm Workers Week.

Violent and Destructive Acts: The Conference resolved to call upon citizens of Florida to avoid participation in violent and destructive acts against individuals and private or public property.

Peacemaking: It was resolved that the Annual Conference petition the Florida congressional delegation and the President and Secretary of State to reject war as an instrument of national foreign policy, that the deployment of armaments must be controlled, reduced and halted as soon as possible; and that the U.S. announce a national policy not to use nuclear weapons first in any conflict situation. Also, the U.S. shall encourage peacemaking and encourage the Soviet Union to adopt a mutual varifiable freeze on the testing, production and deployment of nuclear weapons.

Conference Develops Fiscal Solvency Plan

On the final day of the Annual Conference May 30, clergy and lay delegates voted to support their Council on Finance and Administration's recommendation "to take a firm and purposeful direction toward fiscal solvency."

The annual audit of conference funds showed a deficit of \$1,564,147 accumulated at the end of fiscal year 1984. Council Chairman Keith Ewing of Cocoa said the deficit is a result of spending more than the amount received during the past seven years, inadequate staffing and financial recordkeeping, and the failure of some local churches to pay 100 percent of their apportionments.

The council presented an operating budget for 1986 about 1 percent more than that for 1985. Another \$500,000 was included for deficit recovery and \$250,000 was included as operating reserve and contingency to take care of any shortfall of income (apportionments) over projected expenses.

The council, through a general tightening of budget controls, told the conference it could achieve solvency by 1987.

A special Committee for Fiscal Direction, appointed by the Bishop last year when the Florida Conference first realized its deficit position, also presented recommendations for better budgeting, stewardship and communication.

lution provides for the housing/rental allowances, prescribed to the retired ministers, be allowed for disabled ministers, both ordained or licensed ministers who were minister members of the Florida Annual Conference at the time of their retirement or disability. This resolution also identifies that the Internal Revenue Service recognizes the Florida Annual Conference as the approved organization to designate such an allowance.

Abstinence from Alcoholic Beverages: It was resolved that a recommendation be made to the General Board of Church and Society that a committee be formed of both board members and others with expertise to address the issue of abstinence from alcoholic beverages.

Loopholes in the State Sales Tax: In an effort to suggest ways for the state to more adequately finance common and necessary human services and to oppose the alleged necessity of adopting a state lottery to raise state revenue, it was resolved that the Conference ask the Governor and the Legislature of Florida to look for new funding resources by closing up the many loopholes in the state sales tax and to cease the proliferation of the state sales tax exemptions, with the exception of food and medicine.

The Family Farm: Since the land is a gift of God's creation and we have been charged by God with the stewardship of the land, and since the family farm has provided an environment conducive to the growth of human personality, the enrichment of family life and well being, and since the economic system and society have put undue stress on the family farm, it was resolved that there be an affirmation of the presence of the family farm with an emphasis on helping through grants and low-interest farm loans, compensation for recent losses due to citrus canker outbreaks-and a moratorium on farm foreclosures until the present crisis is over.

Apartheid: The Conference resolved to express strong opposition to the Apartheid policies of the Government of South Africa and to go on record as supporters of human rights.

Ethnic Minority Local Church: The conference resolved that the missional priority of developing and strengthenthe ethnic minority local church for witness and mission be continued and that the unfinished task of providing resources, education, recruitment, leadership development and support for ethnic minority local churches be implemented by the total church. It was requested that a progress report by districts be made to support evidence of progress at next year's annual conference.
