Fall Stewardship Campaign Will Be "Pony Express"

Determining that a fresh approach is just as needed in fundraising as in crop raising, Stewardship Chairpersons Walli Beall and Vereen Smith have proposed that the campaign for next fall take on a new and different look.

The Finance Committee on April 9 approved their recommendation that a campaign called "The Pony Express" be used. "We want to involve the total membership of the church more than in a 'letters only' campaign," Mrs. Beall said.

Successfully used at 253 other Florida Conference churches, this particular vehicle for fundraising features both active involvement and privacy. It makes use of a home-to-home relay approach.

The principle underlying the Pony Express campaign is its encouragement of every member to feel "ownership" in the budget campaign.

Carrol Dadisman will serve as general chairman of the stewardship drive and Luke Blanton will assist him in providing leadership.

Barbara Shores Is Named Christian Education Director

Barbara Shores of Murray, Kentucky, will join Trinity's staff on June 8 as director of Christian education.

Now in her sixth year as director of Christian education at First United Methodist Church, Murray, Miss Shores was selected by a search committee to fill the position formerly held by Gayle Jordan.

She received a master of arts degree from Scarritt Graduate School, Nashville, in 1980 and a bachelor of arts degree in elementary education with a minor in early childhood education from Florida Atlantic University, Boca Raton.

She has also attended numerous continuing education events related to her work during the past five years.

During 1974-75 she was a substitute teacher in the Palm Beach County Schools, and from 1976 until 1979 she directed a child care center sponsored by the First Baptist Church, Boynton Beach. While attending Scarritt, she worked in the public relations office and served as a graduate assistant in the Christian Education Department.

Miss Shores' special interests for ministry include Christian education for children, youth, young adult and family ministries, leadership develop-

ment, long range planning and resourcing. The program at First UMC of Murray has grown extensively under her leadership. Numerous adult and children's Sunday school classes have been added and youth participants increased from four to 50.

The Christian education director has held several leadership roles in

the United Methodist Annual Conference serving the Kentucky area. She was president of Conference Christian Education 1981-82, a member of Education Work Area 1980-1985, Age-Level Family Ministries 1985-present, Conference Children's Coordinator 1982 to present, and a member of the Conference Finance Committee since 1985.

Born in Oxford, N.Y. in 1954, Barbara Shores moved with her family to Boynton Beach, Florida, in 1966. She has a sister and three brothers, one of the latter an ordained minister serving the Blue Ridge United Methodist Church in North Georgia.

She enjoys singing in the choir and after playing the saxophone, oboe, and clarinet in high school and college, played in the summer community band in Murray. She is a competitive bowler and a beginning tennis player.

She enjoys such crafts as needlepoint, counted cross-stitch, toll painting, candle-wicking, macrame, and plastic canvas. She also enjoys boating and is an avid reader.

Miss Shores was selected from about a dozen applicants, three of whom were interviewed by the search committee.

Pentecost Offering To Be Dedicated To Missions May 18

One of the great events of Trinity's year, the annual Pentecost Emphasis, will climax on Pentecost Sunday, May 18. We will dedicate the offerings of thanksgiving accumulated by Trinity members during the Easter-to-Pentecost special emphasis, and the proceeds of the "Bread for Brazil" bake sales conducted at the church on April 13 and April 20.

This year all Pentecost offerings and bread sale proceeds will go to support the work of our missionaries in Brazil, Gordon and Teca Greathouse.

Through Gordon Greathouse's visit to Tallahassee last fall and through recent letters, there is a new awareness among Trinity members of the mission work we support in Brazil. In this atmosphere, the Commission on Missions decided to label this year's emphasis, "Bread for Brazil" and to contribute the Pentecost offerings to the Greathouse ministry.

As the emphasis began last month, missions Co-chairman Duane Clark received another letter from Gordon Greathouse in which he provided more details of the valuable service—and of the pressing needs—at the community center that is the focus of their ministry.

"The medical program is being expanded," Gordon wrote. "At present we have a pediatrician once a week. This doubles what we were doing last year and we hope that soon we can include a gynecologist and general practitioner. Part of the payment we

make to the doctor comes from the donation made by your church. All of the costs for equipment repair and new equipment comes from that donation. We know this service is important to people in the community. Most cannot see a doctor, and those that can often can't get the medicine that is prescribed. We provide most medicines through free samples that we get from doctors. In the future, we will have to expand our medical facilities with a reception room area."

Gordon also wrote: "Another area that we have expanded this year is work with young teenagers. The problems in the slums are very serious for kids 12-16 years old. Drugs, teen prostitution, crime, etc., are very like-

ly activities if the kids don't get good orientation, role models and discipline. Although our program is still small, we have 50 young teenagers working with a judo teacher. He is very effective and particularly helps the boys avoid problems. We hope to soon start with a young woman who will develop recreational activities especially for the girls. Teca has been coordinating this activity and has a big influence on them . . ."

"We really appreciate the help you and others have given us . . . What is even more important to us, however, is feeling that we are a part of a joint mission. It is difficult and tiring to be on the front lines trying to develop a program. Even if you know the pro-

gram is important and what God wants you to do, it helps to feel that there are people back home who care and share your concern.

"We have felt this from you and people at Trinity and thank the Lord for the love He has put in your hearts."

For Trinity members, the Pentecost emphasis and offerings for Brazil provide an opportunity for US to "feel a part of a joint mission"—a mission that obviously is accomplishing much a mong impoverished, uneducated people who need our help.

With a generous response from Trinity members, this year's Pentecost emphasis will be the most effective ever.

We Are All Ministers

Who are the ministers of Trinity Church? Our initial response to this question, doubtlessly, would be to name those of us who hold clergy or lay professional staff positions. Our theology, however, and I trust our personal understanding of and response to Christian discipleship, insists that all Christians are ministers and, therefore, that all of Trinity's members are ministers of Trinity Church.

Some of our members are quite intentional in their ministry. Week after week I become aware of tender and loving deeds done for Christ's sake by Trinity members for family members, neighbors, friends, some of whom are part of our fellowship and some of whom are not, Each new revelation of these unheralded ministries fills me with the grateful realization that our church is indeed being the church.

I want to acknowledge one very special minister of Trinity Church. For many years Mary Draper was a part-time member of our business office staff. When she retired from this position a few years ago she decided that she now had time to do something she knew would meet a very real need, and therefore committed herself to it. Since that time she has visited Trinity members week after week in the hospitals and nursing homes of our community. She may have a record of the number of calls she has made—they would total in the hundreds-but, if so, she has never mentioned it. In fact, she doesn't talk of this magnificent ministry at all. It is her ministry, and it is as self-directed as she is self-effacing about it. I know of it only because those she visits tell me what her cheerful, friendly and caring presence means to them.

Through the unheralded ministries of Mary Draper and many, many others in our fellowship, Trinity Church is being the church. I thank God for

Report From Board Of Trustees

Trinity's Board of Trustees took the following actions during a meeting on April 7.

- Peggy Hughes reported that the current phase of furnishing for Trinity Hall is complete except for window treatments that are yet to be installed in the church library. She also reported that the new committee has done a complete walk-through of the buildings that were not included in the Trinity Hall modernization with the aim of developing a long range plan for maintenance, repair and replacement in the Sanctuary-Chapel wings. The committee hopes to have this plan to the Trustees by midsummer.
- Spencer Burress reported that the leaks in the Sanctuary roof had been investigated by Billy Owens, the roofing contractor who has just completed the roof repair on Trinity Hall. Owens feels that the problems may be relatively simple to correct and may stem from the internal gutter system under the slate roof. Owens has been directed to proceed with repairs on one of the leaks to determine if the repair he plans will solve the problems.
- Walli Beall, chairperson of the Parsonage Committee, reported that her committee has been working to prepare the Lawson Street Parsonage for the new associate minister soon to be appointed to Trinity. Furnishings from the Spence Street parsonage and the Lawson Street parsonage are being combined to make the Lawson Street home as functional and comfortable as possible.
- Trustees voted that the asking price for the Spence Street parsonage be lowered from \$110,00 to \$95,000 on the advice of Realtor Sue Mc-Kemie and appraiser J. D. Williamson. Little interest has been shown in the property at the higher price.
- Eleanor Smith gave an up-date on the recreational facility. After the first bids came back several times above budget, Mrs. Smith and her

committee have been meeting with the architect to redesign the area to bring the plans in line with the projected budget.

- J. D. Williamson and Ernest Menendez are working together on a churchwide inventory of furnishings. Menendez worked on one previously and developed an outline that he feels the Trustees must study before more work is to be done. Study of the outline was to be made at the next Trustees' meeting.
- Trustees voted to name the church library in recognition of the longtime membership and support of Trinity of Mr. and Mrs. Guy McKenzie, Sr. as well as their generous challenge gift that gave the Trinity Hall modernization effort its exciting beginning.

Mission Donation Brings Korean Response

Trinity's Commission on Missions has received a belated expression of appreciation from the United Methodist World Mission-Korea for a scholarship contribution made last year.

In January 1985 Trinity had a churchwide study of Korea. At a Korean Family Night Festival, the special offering of \$98.64 was given. After going through the proper channels, the money reached the mission in Seoul last September.

The Rev. Gene Matthews of the mission wrote:

"We are finally entering the blessed season of spring in Korea and, although the winter just past was a relatively mild one, by Korean standards, we are greatly refreshed by the arrival of spring. Over 300,000 people recently atttended the Easter sunrise service. This was down somewhat from years past but still a dramatic participation by this 100-year-old church. Furthermore, the attendance at this ecumenical service must be considered in the context of the several million who participated in their own services that day. I came to Korea in 1956 when the percentage of the population considered Christian was around 5% and now thrill at reports which place the figure around 25%.

"As I have said in the past, this kind of dramatic growth is not without problems. The church is still confused organizationally and in terms of identifying its own role in Korean society, a confusion, I might add which is not limited to the Korean Church alone. But even as the church struggles with how it ought to be obedient to the will of God, it stands blessed as one of the remarkable stories in Christian history. Korean Church leaders and the missionaries who work along side them fully acknowledge the role played by faithful supporters like you."

When the Church Library was reorganized last summer, general Library Regulations were published in the September 1985, Trinity Tidings. Due to some recent incidents, the Library Committee feels it necessary to add more explicit regulations regarding the use of the Library.

Guidelines for Use of McKenzie Library

These are as follow:

- 1. No food or drink is to be taken into the Church Library at any time. Signs are to be posted stating this. (We assumed this was understood, but evidence shows it is not being followed.)
- 1. No committee meetings or other meetings, but those of the Library Committee, are to be held in the Church Library except when the Conference Room already has been booked, and only then when cleared with the staff person responsible for building usage.
- 3. Small children who may be brought to any meeting should not be allowed to roam over the Library.
- 4. Small children brought to the Library by parents who are selecting books must be strictly supervised.
- 5. Persons in charge of a committee meeting held in the Library must assume all responsibility for the condition of the Library. The Library should be left in the same condition as it was found.
- 6. Door to the Library must be relocked upon leaving by anyone who has unlocked and entered the Library for any purpose except during posted library hours. This applies particularly to the front door which opens onto the arcade and thus to the street.



Other household items have also been donated. One of the new buildings is pictured above, and an interior view shows a living area in need of furnishings and blinds.

The Commission on Missions is urging Trinity members to donate to the "Buy a Blind" fund or make a gift toward purchase of another household item to help make these cottages a home for the students at Vashti Center.

Another important project underway at Vashti Center, being sponsored by Tallahassee Volunteers in Mission and Trinity's Commission on Missions, is renovation of this 70-year-old dairy barn into a recreational center.

Dr. Kalaf Challenges Scarritt as Term as Chairman Nears

Trinity Senior Minister Walter N. Kalaf presided at his last meeting of the Scarritt Graduate School Trustees in Nashville April 16-17. His six-year term as chairman officially ends in October.

With seven years of service to the graduate school for Christian educators and church musicians, Dr. Kalaf will continue to serve as a member of the Trustees' Executive Committee.

During his tenure, the United Methodist school made some major changes. Established 94 years ago by women of the Methodist Church as a place to train missionaries, Scarritt College was overseen by the Board of Global Ministries.

Under the guidance of current President Don Welsh and with the help of its Board of Trustees, the institution was turned over to the UM Board of Higher Education and Campus Ministry and faced its first major decision: Should the school be closed down or redirected?

At his first meeting as chairman, Dr. Kalaf saw the Trustees adopt a consulting group's recommendation that the upper division of the college be phased out and it become a graduate school in which master of music and master of Christian education degree programs be offered.

Since then President Welsh has assembled what is said to be the strongest Christian education and church music faculty in the country.

In an address as retiring chairman on the Scarritt campus April 16, Dr. Kalaf said Scarritt "has been a beacon

of light in a church which has tended

to lose its way regarding the essential servanthood nature of Christian min-"The leaders are servants of the Church, not its masters. They belong

to the Church; not the Church to them. Gifts are given for specific tasks. The Spirit gives the gifts in order to accomplish what the Church is established to do in the world . . . "All of this is to say that in this

time, as the Church seeks to understand and redefine ministry, my hope is that Scarritt will continue to be what it was founded to be . . .

Dr. Kalaf was named to the Trustees following service on the UM lage in Nashville.
